

Ordinance No. 617

Oct 4, 1912

An ordinance requiring the Albany Canal, Water, Transportation and Lighting Company, its successors or assigns, to enclose its canal in the City of Albany, Oregon.

Whereas there was granted by the Common Council of the City of Albany on June 10, 1902 to the Albany Canal, Water, Transportation and Lighting Company, its successors and assigns, the right to maintain a canal and to cause water to flow in and along the same, over certain streets in the City of Albany, Oregon, and

Whereas the canals maintained by said The Albany Canal, Water, Transportation and Lighting Company, its successors or assigns, have been kept in an open condition, which is dangerous to the public, and

Whereas the water supply furnished the inhabitants of the City of Albany is taken from said canal at or near the end thereof and said water is liable to pollution and infection, therefore

The People of the City of Albany do Ordain as Follows-

Section 1. The Albany Canal, Water, Transportation and Lighting Company, its successors or assigns is hereby required to properly enclose with Corrugated iron pipe or reinforced ^{concrete} culvert all of said canals within the City of Albany, Oregon, within Eight months from the passage of this ordinance.

Section 2. The said The Albany Canal, Water, Transportation, and Lighting Company, its successors or assigns shall place said canal when so enclosed at such a depth that the top of said corrugated iron or concrete culvert shall be at least eighteen inches below the established grade of the street or streets in which said canal is laid.

Section 3. At any time after Eight months from the passage of this ordinance any person, firm or corporation who shall maintain any open canal in violation of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine not less than \$50.00 and more than \$100.00 and each day of continuance shall be a separate offense.
