

Ord 693

An ordinance authorizing the Mayor and Recorder to enter into a contract with Dr. Deal & Son for the right to build a main sewer across the property owned by Dr. Deal & Son on Oak Street extended according to the specifications for said sewer.

Whereas the Council of the City of Albany has to run the main sewer along a main sewer on Oak Street and Oak Street extended, with an extension side pass through the property of Dr. Deal & Son, a corporation and it will be necessary in order to build said sewer to dig the said main sewer of said Dr. Deal & Son and dig through the said main sewer and tear down the partition fence of the said Dr. Deal & Son, and

Whereas said Dr. Deal & Son has agreed that the City of Albany may build said sewer through the property of Dr. Deal & Son and drain said sewer into a main sewer in the said fence in the condition that the said main sewer, as far as possible, be repaired in as good condition as the same now is and in such condition that it will not leak and that the sheep pen, in the pasture of said Dr. Deal & Son shall be taken care of so that the same will do not get out of the inclosure and the said fences repaired and put in as good condition as the same now are, and the business kept in said property, and in case there is any damage to said sewerment that any compensation will be ascertained by the said Dr. Deal & Son for a right of way through said land.

Therefore in consideration of the premises:

The People of the City of Albany do enact as follows:

Section 1. That the Mayor and Recorder of the City of Albany be and they are hereby authorized and directed to enter into a written contract with the said Dr. Deal & Son in words and figures as follows, to-wit:

This Contract and agreement to wit and entered into this _____ day of October 1913 by and between the City of Albany, a municipal corporation, Party of the first part and Dr. Deal & Son a private corporation, Party of the second part.
