

An ordinance declaring a surplus on account of the construction of a lateral sewer by W. T. McAllister and P. H. Walton beginning at the east end of lateral sewer constructed in Block 68, thence running easterly 71 feet, to sewer constructed through Broadway Street, thence beginning at east end of said sewer constructed through Broadway Street, thence in a westerly direction 57 feet, thence easterly 133 feet, and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate within said Block 68 in the City of Albany heretofore assessed and assessed of record in the Society City Signs in the City of Albany, Oregon for making such improvement their proportionate share of such surplus.

The People of the City of Albany do Ordain as follows:

Section 1. That a surplus is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon and W. T. McAllister and P. H. Walton for the construction of lateral sewer beginning at the east end of lateral sewer constructed in Block 68, thence running easterly 71 feet, to sewer constructed through Broadway Street, thence beginning at east end of said sewer constructed through Broadway Street, thence in a westerly direction 57 feet, thence easterly 133 feet, and in favor of the several owners of the various parcels of real estate within said Block 68 heretofore assessed for making such improvements.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Book of City Signs in the surplus column thereof a credit based upon the several amounts heretofore assessed and levied therein to defray the cost of the improvement of said lateral sewer; said surplus being in favor of the following named persons owners or reputed owners of said various parcels of real estate and in sums as follows, to-wit:
