

An Ordinance declaring a surplus on account of the improvement, by W. T. McAllister and P. H. Walton, of Eighth Street from the East line of Jackson Street to the West line of Gary Street, excepting the intersection of Lafayette Street, in the City of Albany, Oregon, and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Hooket of City Sines in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

The People of the City of Albany Do Ordain as Follows:

Section 1. That a surplus of 7.67 per cent is hereby ascertained and declared to exist upon the completion of the contract entered in to by and between the City of Albany, Oregon and W. T. McAllister and P. H. Walton for the improvement of Eighth Street from the East line of Jackson Street to the West line of Gary Street excepting the intersection of Lafayette Street, in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Hooket of City Sines in the surplus column thereof a credit of 7.67 per cent, based upon the several amounts heretofore assessed and entered therein to defray the cost of improving said street; said surplus being in favor of the following named persons, owners, or reputed owners of such parcels of real estate and in the sums as follows, to-wit:
