

Lawrence, Albany, Oregon

An Ordinance declaring a surplus on account of the construction of a lateral sewer by W. A. Mc. Clain beginning at the manhole in Ferry Street trunk sewer where same connects with Twelfth Street and running thence easterly along said Twelfth Street parallel with and sixteen feet from the north line thereof, 152 feet to the intersection with the center line of the alley through a Block "A" Central Addition; thence easterly along the center line of said alley and the extension thereof 200 feet to a point in the street or road running northwesterly and northeasterly and 8 feet from the northwesterly side thereof; thence southwesterly along said street or road parallel with and eight feet from the northwesterly side thereof 30 feet, and being a total distance of 432 feet, and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, hereinafter assessed and entered of record in the Hooks of City Lists in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

The People of the City of Albany do Ordain as Follows:

Section 1. That a surplus of 4.92 percent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and W. A. Mc. Clain for the construction of a lateral sewer beginning at the manhole in Ferry Street trunk sewer where same connects with Twelfth Street and running thence easterly along said Twelfth Street parallel with and sixteen feet from the north line thereof, 152 feet to the intersection with the center line of the alley through a Block "A" Central Addition; thence easterly along the center line of said alley and the extension thereof 200 feet to a point in the street or road running northwesterly and northeasterly and 8 feet from the northwesterly side thereof; thence southwesterly along said street or road, parallel with and eight feet from the northwesterly side thereof 30 feet, and being a total distance of 432 feet, and in favor of the several owners of the various parcels of real estate adjacent to said improvement hereinafter assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the books of the City of Albany in the surplus column thereof a bill of 4.92 percent, based upon the several amounts heretofore assessed and entered thereon to defray the cost of the construction of said lateral sewer, said surplus being in favor of the following named persons, owners or reputed owners of such parcels of real estate and in sums as follows, to-wit:
