

## ORDINANCE NO. 373

AN ORDINANCE DECLARING A SURPLUS ON ACCOUNT OF THE CONSTRUCTION OF A LATERAL SEWER BY W.S. WEAVER BEGINNING AT THE MANHOLE IN THE OAK STREET TRUNK SEWER BETWEEN FIRST AND SECOND STREETS AND RUNNING THENCE EASTWARD THROUGH BLOCK 16 IN HACKLEMAN'S THIRD ADDITION TO THE CITY OF ALBANY, OREGON AND DIRECTING THE RECORDER OF THE CITY OF ALBANY TO PLACE TO THE CREDIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT, HERETOFORE ASSESSED AND ENTERED OF RECORD IN THE DOCKET OF CITY LIENS IN THE CITY OF ALBANY, OREGON, FOR MAKING SUCH IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of 2,795 per cent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon and W. S. Weaver for the construction of a lateral sewer beginning at the manhole in the Oak Street Trunk Sewer between First and Second Streets and running thence Eastward through Block 16 in Hackleman's Third Addition to the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens in the surplus column thereof a credit of 2,795 per cent, based upon the several amounts heretofore assessed and entered therein to defray the cost of the making of said improvement; said surplus being in favor of the following named persons, owners or reputed owners of such parcels of real estate and in sums as follows, to-wit:


