AN ORDINANCE TO ASCERTAIN AND DETERMINE THE PROBABLE COST OF GERTAIN IMPROVEMENTS WHICH THE COUNCIL OF THE CITY OF ALBANY, ORE GON HAS DETERMINED IN RESOLUTION NO.3, ADOPTED BY SAID COUNCIL ON THE 9th DAY OF FEBRUARY, 1921
TO MAKE ON PINE STREET FROM THE NORTH LINE OF SALEM ROAD NORTH TO THE WILE LAMBTE RIVER: TO ASCERTIN, ASSESS, DETERMINE AND DECLARE THE PROPORTIONATE SHARE OF SUCH PROBABLE COST OF SUCH IMPROVEMENT OF SAID PINE STREET THAT IS ASSESSED UPON EACH LOT OR PART THEREOF ADJACENT TO SAID PART OF PINE STREET TO BE SO IMPROVED: TO DIRECT THE RECORDER OF SAID CITY TO ENTER A STATEMENT OF SUCH ASSESSMENT IN THE DOCKET OF CITY LIENS AS PROVIDED BY THE CHARTER OF SAID CITY.

WHEREAS, on the 12th day of August, 1920 the Council of the City of Albany duly adopted a resolution requiring the City Engineer of said City to make plans and specifications for the improvement of Pine Street from the North line of Salem Road north to the Willamette River in the following manner, to-wit:

First: By grading said street to the proper subgrade. Second: By graveling said street.

Third: By the installation of a proper drainage system.

and for the estimates of the work to be done on said portion of Pine Street
and the probable cost thereof and requiring that such plans, specifications,
estimates and probable cost be filed in the Recorder's Office of said city of
Albany, Oregon, and resolution being en orsed "Resolution No. 21" and adopted
on the 12th day of August 1920; and

WHEREAS, the City Engineer of said city of Albany, pursuant to eaid Resolution No. 21 made plans, specifications and estimates as directed by said Resolution for the improvement of said Pine Street in the manner specified in saidResolution No. 21 and filed said plans, specifications and estimates in the Recorder's Office in said City on the 10th day of November, 1920; and

WHEREAS, the said Council on the 9th day of February, 1921, by Resolution No.3, duly adopted by said Council, determined and resolved that it deemed it expedient and that said Council proposed and intended to improve Pine Street from the North line of Salem Road north to the Willamette River in the manner provided in said Resolution No. 3; and

WHEREAS, an and by said Resolution No. 3, adopted as aforesaid by the Council, the Recorder of said City was duly ordered and directed by said council to give notice of said proposed improvement of said Pine Street from the North line of Salem Road north to the Willamette River as provided by the charter of said City and

WHIRMAS, the Recorder in pursuance of said order and direction of the Council of said City of Albany did duly give notice of said proposed improvement of said Pine Street in the manner provided by the charter of said city; and

WHEREAS, the said Council in and by said Resolution No. 3 ascertained and determined the probable dost of making said improvement of said Pine Street to be paid by the owners of the real property adjacent to said portion of said Pine Street to be improved as specified in said Resolution No.3 to be the sum of \$ 1332.42

THEREFORE THE PEOPLE OF THE CITY OF ALBANY DO ORDAI! AS FOLLOWS:

Section 1. That Pine Street in the City of Albany, Oregon from the North line of Salem Road North to the Willamette River, shall be improved as follows:

First: By grading said street to the proper grade.

Second: By graveling said street.

Third: By constructing inlets.

Fourth: By laying vitrified sewer pipe.

Fifth: By grubbing and clearing said street.

Sixth: By tapping sewer.

All in accordance with said Resolution No.3 nd the plans, specifications and estimates for said improvement filed by the City Engineer with the Recorder of said City of Albany on the 10th day of November, 1920.

Section 2. That the probable cost of making said improvement of said Pine Street in the City of Albany, Oregon from the north line of Salem Road north to the Willamette River in the manner heretofore determined by the Council of the said City of Albany in and by said Resolution No. 3 by grading and graveling said street and by constructing a proper drainage system to be paid by the owners of the real property adjacent to said portion of Pine Street is hereby declared to be the sum of \$ 1332.42.

Section 3. That the proportionate share of said probable cost of such improvement of said Pine Street assessed upon each lot or part thereof adjacent to said part of Pine Street to be improved as aforesaid and as determined by said Council in and by said Resolution No.3 is hereby ascertained and declared to be the sum set and placed immediately after the separate description of each of such lots or parts thereof as follows:
