ORDINANCE NO. 984.

AN ORDINANCE TO ASCERTAIN AND DETERMINE THE PROBABLE COST OF CERTAIN IMPROVEMENTS WHICH THE COUNCIL OF THE CITY OF ALBANY, OREGON, HAS DETERMINED IN RESCULUTION NO.4, ADOPTED BY SAID COUNCIL ON THE 28th DAY OF FEBRUARY, 1991, TO MAKE ON PINE STREET FROM THE NORTH LINE OF EIGHTH STHEET TO THE SOURH LINE OF SANTIAM STREET; TO ASCERTAIN, ASSESS, DETERMINE AND DECLARE THE PROPORTIONATE SHARE OF SUCH PROBABLE COST OF SUCH IMPROVEMENT OF SAID PINE STREET THAT IS ASSESSED UPON EACH LOT OR PART THEREOF ADJACENT TO SAID PART OF PINE STREET TO BE SO IMPROVED: TO DIRECT THE RECORDER OF SAID CITY TO ENTER A STATEMENT OF SUCH ASSESSMENT IN THE DOCKET OF CITY LIENS AS PROVIDED BY THE CHARTER OF SAID CITY.

WHEREAS, on the 26th day of February, 1921, the Council of the City of Albany, Oregon, duly adopted a resolution requiring the City Engineer of said city to make plans and specifications for the improvement of Pine Street from the North line of Righth Street to the South line of Santiam Street in the following manner, to-wit:

First: By grading said street to the established grade. Second : By graveling said street.

Third: By the installation of a proper drainage system.

and for the estimates of the work to be done on the said portion of Pine Street and the probable cost thereof ad requiring that such plans, specifications, estimates and probable cost be filed in the Recorder's Office of said City, said Resolution being endorsed "Resolution No 1" and adopted the 26th day of January, 1921;

WHEREAS, the City Engineer of said City of Albany, pursuant to said Resolution No. 1 made plans, specifications and estimates as directed by said Resolution for the improvement of said Pine Street in the manner specified in said Resolution No.1 and filed said plans, specifications and estimates in the Recorder's Office of said city on the 9th day of February, 1921; and

WHEREAS, the said Council on the 28th day of February, 1921, by Resolution No. 4, duly adopted by said Council, determined and resolved that it deemed it expedident and that said Council proposed to improve Pine Street from the North line of Eighth Street to the South line of Santiam Street in the man er provided in said Resolution No.4; and

WHEREAS, in and by said Resolution No.4, adopted as aforesaid by the Gouncil, the Recorder of said City was duly ordered and directed by said Council to give notice of said proposed improvement of said Pine Street from the North line of Mighth Street to the South line of Santiam Street as provided by the charter of said City; and

WHEREAS, the Recorder in pursuance of said order and direction of the Council of said City of Albany did duly give notice of said improvement of said Pine Street in the manner provided by the charter of said oity; and

Whereas, the said Council in and by said Resolution No.4 excertained and determined the probable cost of making said improvement of Pine Street to be paid by the owners of the real property adjacent to said portion of Pine Street

to be improved as specified in said Resolution No.4 to be the sum of \$885.00

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That Pine Street in the City of Albany, Oregon from the North line of Eighth Street to the South line of Santiam Street, shall be improved as follows:

First: By grading said street.

Second By graveling Said street.

Third: By clearing and grubbing said street.

Fourth: By laying drain tile.

All in accordance with said Resolution No.4 and the plans and specifications for said improvement filed by the City Engineer with the Recorder of said City of Albany on the 9th day of February, 1921.

Section 2. That the probable cost of making said improvement of said Pine Street in the City of Albany, Cregon, from the North line of Eighth Street to the South line of Santiam Street in the manner heretofore determined by the council of said City of Albany in and by said Resolution No.4 by grading said street to the established grade; by graveling said street; and the installation of a proper drainage system to be paid by the owners of the real property adjacent to said portion of Pine Street is hereby declared to the sum of \$885.00

Section 3. That the proportionate share of said probable cost of said improvement of said Pine Street assessed upon each lot or part thereof adjamicent to said part of Pine street to be improved as aforesaid and as determined by said Council in and by said Resolution No.4 is hereby ascertained and declared to be the sum set and pleed immediately after the separate description of each of such lots or parts thereof as follows:
