ORDINANCE NO. 1138

A BILL FOR AN ORDINANCE Declaring a surplus on account of the improvement by C. E. Davis on Front Street from the West line of Geary Street West to the West line of Cleveland Street in the City of Albany, Oregon, and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon for making such improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of Fifty-three Dollars (\$53) is hereby ascertained, determined and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and C. E. Davis for the improvement of Front Street from the West line of Geary Street West to the West line of Cleveland Street in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens in the surplus column thereof a credit in favor of the following named persons, owners, or reputed owners, of such parcels of real estate and in the sums as follows, to-wit:
