Seotion 1. That for the purposes set forth herein and in the manner provided by law and this ordinance, a special eleotion shnil be held in the City of Albany, oregon, on Tugedny, Novamber 2, 1925, conmenolng at the hour of 8:00 A.M. and continuing until 5 olclook P.lf. of baid dny.
section 2. Sald epecial election alanil je conducted in the manner provided by lam and by Ordinanoe No. 1232, pasned by the Council september 22, 1926, and approved by the fayor Septemor 22, 1926, providing for the holding of a speoial election on gald lovember 2 , 1926, and tise judges and clorks and votiniz places nained and resi,gated in said ordinance Yo. 1232, bhall be the same juiges, olerkm and voting placee respectivelir for the holdiñ of the special electdon provided for by this ordiamee, and aald opecial elestion shall be held in all reapects in accordanca with the provisions of said Ordinance No. 1232, and of Article iv of Chapter I of the chartor of said City.

Section 3. The Reaorder of the City of Albany is hereby instructed to gite notioe of and special election in the manner provided by drticle III of Chapter I of the Charter of sald City.
section 4. That at said specinl election the question of the smexation of the territory leacribed in Resolution No. 41 adopted by the Counoil october 2, 1926, shall be eubmitted to the legal voters of the Clity of Nibany for their approval or rejection, to-wit:

Beginning at the point where the mouth ilne of lith street, if extended enstarly, interssots the wast line of ferry Street, in the City of fibany, Linn County, Orepon, and running thence southerly mlons the west line of Ferry Street, extended, to the north line of the County road comonly lenown as 15 th street; thence westerly along the north line of sald listh streat to the satheast corner of block $C$ in Central Addition to sald City; thenoc northeasterly alon the eastern bourdaryline of and Block $C$ to the northeast corner of said block; thence easterly to the place of beginning, all lying and being in Linn County, Oregon.

Seotion 5. Whereas, existing conjitions are such that this ordinence is necessary for the protection of the peace, health and gafety of tha people of the City of Albony, an emergency is hereby djolared to exist, and this ordinance shall be infull force and effect from and aftar its passage by the Council and approval by the ilayor.
