

ORDINANCE No. 1335

An ordinance levying an assessment upon the west 1/4 of the southeast quarter and the east 1/4 of the southwest quarter of block No. 47 in Hackleman's Second Addition of the City of Albany, Oregon, and directing the Recorder to enter a statement of said assessment in the docket of City Liens.

WHEREAS, on the ---- day of August, 1930, the noxious weeds, vines, grass and other vegetation made such a growth on the west 1/4 of the south east quarter and the east 1/4 of the southwest quarter of block 47 in Hackleman's Second Addition to the City of Albany, Oregon, said property being that of Hannah G. Fisher Estate, that said growth then constituted a public nuisance and a fire hazard endangering the property of others in the vicinity thereof, and

WHEREAS, under and by virtue of the authority of Ordinance No. 1321 the chief of the fire department of the City of Albany did on the ---- day of August, 1930 notify the said owners of said property of the existence of said nuisance in the manner provided by law, and said notice required the said owners to remove the same within five days thereafter as required by said ordinance No. 1321, and in case of their failure to so remove the same within such time then the City of Albany would cause the cost of such removal to be charged against and to become a lien on said property, and

WHEREAS, the owners or reputed owners of said property failed to remove or cause said nuisance to be removed within the time as provided by law and said notice, and

WHEREAS, the Chief of the Fire Department of the City of Albany, on behalf of said City removed said nuisance from said property and has kept and reported a statement of the cost thereof to the Council of said City, which said report is now on file with the Recorder of said City, and which said report contains a description of the property from which said nuisance was by him removed, and the name of the owner or reputed owner thereof, and is in all respects in due and legal form, and which said report has been approved by the Council;

THEREFORE, THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That there be, and is hereby assessed upon and against the west 1/4 of the southeast quarter, and the east 1/4 of the southwest quarter of block 47 in Hackleman's Second Addition to the City of Albany, Linn County, Oregon, said property being that of Hannah G. Fisher Estate, the sum of \$21.50, that being the cost of removal of a nuisance therefrom, as hereinabove set forth; and the Recorder of the City of Albany is hereby authorized and directed to enter a statement of said assessment and the amount thereof in the docket of City Liens of the City of Albany in the manner as provided by law.
