ORDINANCE NO. 1365

AN ORDINANCE prohibiting the owners, lessees, proprietors or employees of public billiard rooms and public pool rooms from permitting minors under the age of eighteen years to engage in any games therein or to loiter therein and providing penalties for violation of the provisions of this ordinance and repealing all ordinances and parts of ordinances conflicting herewith.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person, being the owner, lessee, proprietor or employee, of any public billiard room or public pool room to suffer or permit any minor under the age of eighteen years to engage in any game of pool, billiards or any other game in any such public billiard room or public pool room either for amusement or otherwise, or to loiter therein. Any person upon conviction of violating the provisions of this ordinance shall be punished by a fine of not less than \$5.00 nor more than \$25.00, or by imprisonment in the city jail for a period of not less than five nor more than twelve days, or by both such fine and imprisonment at the discretion of the court.

Section 2. All ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.



ORDINANCE NO. 1366

AN ORDINANCE authorizing the committee on fire and water to purchase from Howard-Cooper Corporation five hundred feet of fire department hose and appropriating the sum of \$416.50 of the general funds of said City for the payment of the same.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the committee of the Council on fire and water of the City of Albany, Oregon, is hereby authorized and directed to purchase from Howard-Cooper Corporation five hundred feet of Brown King brand Fire Department hose, one and one half inch internal diameter at and for the agreed price of \$416.50 net.

Section 2. That there be and is hereby appropriated from the general funds of the City of Albany the sum of \$416.50 in payment of the fire hose referred to in Section 1 of this ordinance, and the Recorder of said City is hereby authorized and directed to make, execute and deliver to Howard-Cooper Corporation the general fund warrant of said City in the amount hereby appropriated.


