## ORDINANCE NO. 1389

AN ORDINANCE to amend Section I of Ordinance No.1388 entitled "AN ORDINANCE authorizing a loan for a term of years in the sum of seventy thousand five hundred and no/ICO (\$70,500.00) Dollars, under and pursuant to Chapter 156 of the Laws of Oregon for the year 1933 as amended by Chapter 205 of the Laws of Oregon for 1935, for the purpose of refunding certain outstanding bonded indebtedness of the City of Albany, Oregon, providing for the issuance and sale of the refunding bonds of the City of Albany, Oregon, for such loan and declaring an emergency, "passed by the Council on the 22nd day of May, 1935, and approved by the Mayor on the 23rd day of May, 1935.

THE PROPIL OF THE CITY OF ALBANY, ORRGON, DO ORDAIN AS FOLLOWS:

That Section I of Ordinance No. 1388 entitlei

"AN OMDINANCE authorizing a loan for a term of years in the sum of seventy thousand five hundred and no/IOO (\$70,500.00) Dollars, under and pursuant to Chapter I56 of the Laws of Oregon for the year I933 as amended by Chapter 200 of the Laws of Oregon for I935, for the purpose of refunding certain outstanding conded indebtedness of the City of Albany, Oregon, providing for the issuance and sale of the refunding Bonds of the City of Albany, Oregon, for such loan and declaring an emergency."

Passed by the Council on the 22nd day of May, 1935,

and approved by the Mayor on the 23rd day of May, 1935, be and the same is hereby

amended to read as follows:

Section I. That for the purpose of obtaining funds to pay and refund the outstanding bonded indebtedness of the City of Albany, Oregon, represented by the unpaid Storm Sewer Bond issue dated January I5, 1924, in the sum of Forty-five Thousand Five Hundred and no/IOO (\$45,500.00) Dollars, and the unpaid Bridge Bond issue dated July I,1925, in the sum of Twenty-five Thousand and no/IOO (\$25,000.00) Dollars, as hereinabove set forth, there shall be issued the general obligation refunding bonds of the City of Albany, Oregon, in the sum of Seventy Thousand Five Hundred and no/IOO (\$70,500.00) Dollars, said bonds to be dated July I,1935, and to be in denominations of \$500.00 each, numbered one (I) to One Hundred forty-one (I4I) and to mature as follows, to-wit:

Pach of said bonds shall be signed by the mayor of the City of Albany, Oregon, attested by the Accorder of said City, registered by the City Treasurer of said City and numbers one (I) to seventy (70), both inclusive, of said bonds shall bear interest at the rate of two and one-quarter (24%) percent per annum and numbers seventy-one (71) to one hundred forty-one (I41), both inclusive, of said bonds shall bear interest at the rate of three (3%) percent, per annum, said interest on each and all of said bonds payable semi-annually on the first day of January and the first day of July of each year subsequent to the date of said bonds, principal and interest to be payable in lawful money of the United States of America at the office of the City Treasurer of the City of Albany, Oregon, and said bond issue shall be known as the "1935 Refunding Bonds of the City of Albany, Oregon, Series A".
