## ORDINANCE NO. 1458

AN ORDI. ALCE accepting the offer of the Federal Emergency Administration of Public Works of United States Government granting to the City of Albany, Ore on, the sum of \$9495.00 to aid in financing the construction of a municipal building, including swimming pool filter facilities therein, and the construction of extensions and improvements to street lighting system.

THE PEOPLE OF THE CITY OF ALBANY DC ORDAIN AS FOLLOWS:

Section 1. That the offer of a grant of the Federal Emergency Administration of rublic Works of the United States Government to the City of Allany, Oregon, in the sum of \$9495.00 to aid in financing the construction of a municipal building, including swimming pool filter facilities the rein, and the construction of extensions and improvements to street lighting system be and the same is hereby accepted; which said grant is in words and figures as follows, to-wit:

Subject to the terms and conditions (PWA Form No. 230, as amended to the date of this offer, which are made a part hereof, the United States of America hereby of fers to aid in finencing the construction of a municipal America hereby of fers to aid in financing the construction of a municipal building, including swimming bool filter facilities therein, and the construction of extensions and improvements to street lighting system(all herein called the "Project"), by making a grant to the City of Albany (herein called the "Applicant") in the amount of 45 percent of the cost of the Froject upon completion, as determined by the Federal Emergency of Public Works (herein called the "Administrator"), but not to exceed, in any event, the sum of \$9495.00.
- 2. By acceptance of this offer the Applicant covenants to begin work on the Project as early as possible but in no event later than 8 weeks from the date of this Offer and to complete such Project with all practicable dispatch, and in any event within 4 months from the commencement of construction.
- 3. This Offer is made subject to the express condition that, if the Administrator shall determine at any time that the Applicant has paid or agreed to pay, whether directly or indirectly, a bonus, commission or fee to any person, firm or corporation for attempting to procure an approval of the Applicant's application, or for alleged services in procuring or in attempting to procure such approval, or for activities of the nature commonly known as lobbying performed or agreed to be performed in connection with the application, then the Administrator shall have the right, in his discretion, to rescind this Offer and any agreements resulting helefrom, and, in the event of such rescission, the United States of America shall be under no further obligation hereunder.
