AN ORDIVANCE to regulate the storage and handling of petroleum and petroleum products and volatile oil products and providing a penalty for the violation thereof.

THE PROPLE OF THE CITY OF ALB NY DO ORDAIN AS FOLLOWS:

1

Section 1. No person, firm corporation, or association shall keep or store inside any building or structure or upon anyone's premises or in any public garage within the city limits more than 5 gallons of benzine, gasoline, naptha, or any other hydrocarbon liquid that will take fire and burn at a tempature below 120 degrees Fahrenheit.

Section 2. It shall be unlawful for any person, firm, or corporation to operate a pump for handling gasoline, naptha, or volatile cil products within any building in the City of Albany. It shall be unlawful to pump gasoline through a pump into any building, or from a pump into any container or vehicle within any building and it shall be unlawful to operate any gasoline pump inside any building by the pumping of gasoline through said pump.

Section 3. It shall be unlawful for any person, firm, or corporation or association to install a gasoline pump upon any sidewalk or between any sidewalk and curb or upon any of the streats within the city of albany.

Section 4. Any person, firm, or corporation operating or intending to construct and operate any storage station for the storage or distribution of crude petroleum, or any petroleum products, or any liquid of inflamable character whatwoever, shall make application to the council of the city of Albany for a permit authorizing the construction and operation of such oil storage station. No permit shall be granted for the construction of such station unless the same shall comply with all the requirements of the laws of the state of Oregon; provided, further, that no such permit shall be granted unless each of such storage tanks or a group of storage tanks shall be enclosed with solid concrete or reinforced concrete walls, which said walls shall be capable of retaining one and one-half times the volume of such tanks enclosed, and there shall be no openings in such walls, except a drain pipe with a shutoff valve located at the lowest point thereof.

Section 5. Whenever any person, fire, or corporation shall have distrubed any street, alley, theroughfare, sidewalks, or curbs for the purpose as hereinabove set forth and shall have failed to replace the same in as good condition as the same was before it was disturbed, or shall fail to remove any debris therefrom by reason of such disturbance, the committee on streets and public property of the city of Albany, Oregon, may cause such work to be done as may be necessary to replace said street, alley, thoroughfare, sidewalk, or curbing in good condition, and to remove such debris therefrom. The expense created by such work on the part of said committee shall be borne by the person, firm, or corporation that caused such disturbance and debris to be placed there on, and the amount of such expense shall be recovered from such person, firm, or corporation as in an action at law.

Section 6. Any person, firm, corporation, or association who shall violate any of the provisions of this ordinance shall be deemed guilty of a middemeanor and upon conviction thereof shall be fined in the sum of not less than \$5.00 nor more than \$25.00, or imprisoned for not less than 2 days nor more than 12 days, or shall be punished by both such fine and imprisonment, in the discretion of the court.
