

ORDINANCE No. 1542

A Bill for

AN ORDINANCE to license and regulate persons engaged in the business of operating garbage wagons within the City of Albany, providing a penalty for violation hereof and repealing all ordinances and parts of ordinances in conflict herewith and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. DEFINITION. A "garbage wagon" is hereby defined to be any vehicle operated in the business of hauling garbage within the City of Albany.

Section 2. It shall be unlawful for any person to operate a garbage wagon within the City of Albany without first having obtained a license for that purpose in accordance with the provisions of this ordinance.

Section 3. That the license fee for operating a garbage wagon in the City of Albany shall be \$50.00 per annum, per wagon, payable quarterly in advance. Upon making application therefor and upon payment of the license fee as herein required, the recorder is hereby authorized to issue a license to such applicant, which license shall be effective until December 31st of the year in which the same is issued; provided, the fees therefor are paid to such date, otherwise the license shall expire on the date the payments therefor shall become delinquent as herein required.

Section 4. The Council may by Resolution adopt such rules and requirements as may be deemed by it to be expedient for the control and regulation of the operation of garbage wagons under this ordinance and any failure or refusal of any licensee hereunder to comply with the terms of any such rules or requirements shall authorize the Council to revoke or suspend the license of such licensee.

Section 5. Any person violating any of the provisions of this ordinance shall upon conviction thereof in the Recorder's Court be punished by a fine of not less than \$5.00 nor more than \$100.00.

Section 6. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section 7. Whereas, the peace, health, and safety of the people of the City of Albany is involved, therefore an emergency is hereby declared to exist and this ordinance shall become ~~effective~~ immediately effective upon its final passage by the Council and approval by the Mayor.


