A BILL FOR AN ORDINANCE levying a tax for the ^City of Albany, Gregon, upon the current assessment made upon the taxable property of said ^City for the fiscal year from July 1, 1945 to June 30, 1944, for taxes to become due and payable upon such assessment for said period and to separately appropriate for each department of said City government and other public purposes thereof the amount of taxes so levied as provided by law.

THE PEOFLE OF THE CITY OF ALBANY DO CRDAIN AS FOLLOWS:

Section 1. That it is hereby determined, declared and levied, taxes in and for the City of Albany, Oregon, based upon the current assessment made upon the taxable property in said City for the fiscal year from July 1, 1943 to June 30. 1944, said taxes to be for and to become due and payable within said said period as follows, to-wit:

Section 2. That from the funds derived from the lavy hereby made and determined there is hereby appropriated for the fiscal year beginning July 1, 1943 and ending June 30, 1944, the sums set opposite the respective items as hereinabove set forth.

Section 3. The Recorder of the City of Albany is hereby directed to immediately notify the County Clerk and County Assessor of Linn County, Oregon, of the levy hereby made as provided by law.
