A Bill for

AN ORDINANCE vacating East Eighth Street from the East line of Baker Street extending Easterly a distance of 133 feet in the City of Albany, Oregon.

Whereas, by Ordinance No. 1559 passed by the Council June 9, 1943 and approved by the Mayor June 9, 1943, it was provided for the time and manner of vacating East Eighth Street from the East line of Baker Streat extending Easterly a distance of 133 feet in said City; and

Whereas, the Mayor and Council have deemed it expedient and necessary that said portion of said Street be vacated for the reason that the same is of no value as a street and otherwise for public use; and

Whereas, pursuant to said Ordinance the Recorder of said City gave notice of the vacation of said portion of said Street by publishing the same in the Greater Oregon, a newspaper of general circulation published in the City of albany, Oregon, once a week for four successive weeks, a copy of said notice, together with due proof of publication thereof now being on file in the office of the Recorder of said City; and

Whereas, the Recorder caused copies of said notice to be posted in or near each end of said proposed vacation and in at least two conspicious places within said proposed vacation, proof of the posting of such notices now being on file with the Recorder of said Gity; and

Whereas, the time for the filing of objections or remonstances to said vacation of said portion of said Street has expired and no such objections or remonstrances have been filed; and

Whereas, the time for the hearing of such objections or remonstrances has been filed, and

Whereas, the time for the hearing of such objections or remonstrances has been continued to July 28, 1943, at the regular meeting of the Council on said date and no objections now being on file;

THEREFOR. THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1, That East Eighth Street from the East line of Baker Street extending Easterly 133 feet in the City of Albany, Oregon be and the same is hereby vacated.
