

## ORDINANCE NO. 1668

A Bill For:

An Ordinance to appropriate the sum of \$500.00 of the street fund of the City of Albany, Oregon for the purpose of purchasing a tract of real property of the Southern Pacific Company a corporation situated in the Block No. 20 in Hacklemans second addition to the City of Albany and to authorize the recorder to execute and deliver to the said corporation the street fund warrant of said city in the amount herein appropriated.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That there be and is hereby appropriated of the street fund of the City of Albany, Oregon the sum of \$500.00 for the purpose of purchasing from the Southern Pacific Company, a corporation, the following described real property to-wit:

Beginning at the northwesterly corner of Block 20 in Hacklemans second addition to the City of Albany, Linn County, Oregon and running thence north  $81^{\circ} 03'$  East along the northerly line of said block 264.55 feet to the northeasterly corner of said block; thence South  $8^{\circ} 57'$  East along the easterly line of said block 7.00 feet to a point, which is 10 feet northerly from, when measured at right angles to, the center line of the relocated Santiam Canal; thence South  $54^{\circ} 02'$  West parallel with and 10 feet northerly from said center line 74.6 feet to a point in the easterly line of Lot 3, which is 40.8 feet southerly from the northeasterly corner of said Lot 3; thence South  $68^{\circ} 57'$  West 202.5 feet parallel and 10 feet northerly from said center line of canal to a point on the westerly line of said Block 20; thence North  $9^{\circ} 01'$  West along said westerly line 83.3 feet to the point of beginning containing an area of 13, 688 square feet more or less.

Section 2. The Recorder of the City of Albany is hereby authorized to execute and deliver the street fund warrant of said city payable to the Southern Pacific Company in the sum of \$500.00 upon being furnished with a proper deed of conveyance conveying to such city the real property here and above described together with a Certificate of Title in which showing the Southern Pacific Company to be the owner of said property in fee simple, free and clear of incumbrances.
