A BILL FOR:

AN ORDINANCE authorizing the Mayor and Recorder of the City of Albany, Oregon, to enter into a contract with D. F. McKenzie and O. L. Bowman for the improvement of Eighth Street from the west line of Calepooia Street to the east line of Vine Street on the south side of the canal and Vine Street from the south line of Eighth Street Canal to the north line of Ninth Street in the City of Albany, Oregon.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

WHEREAS, by Ordinance No. 1787, of the City of Albany, Oregon, it was ordered that the following streets in said City be im-proved, to-wit: Eighth Street from the west line of Calapooia Street to the east line of Vine Street on the south side of the canal and Vine Street from the south line of Eighth Street Canal to the north line of Ninth Street.

Said improvement to be made in the following manner:

- 1.
- By grading said streets to the proper sub-grade. By installing concrete curbs and gutters wherever nec-.ssary
- By paving said streets with oil mat surface. 3.

and in accordance with the plans, specifications and estimates of Walter W. Larsen, Engineer, then on file in the office of the Recorder of said City; and

WHEREAS, it was provided in said Ordinance that the Recorder of said City of Albany, give notice for bids for the making of said im-provement in the manner provided by law and said Ordinance; and

WHEREAS after due notice and advertisement for bids made WHEREAS after due notice and advertisement for bids made and given by the Recorder according to law and the Ordinance last afore-said, to-wit: on the 16th day of May, 1947, D. F. McKenzie and C. L. Bowman presented to the Council of the City of Albany their bid for making said improvement in the manner aforesaid, which bid was made in due form and in conformity with all the conditions imposed by law and the Council, by which said bid D. F. McKenzis and C. L. Bowman proposed to furnish all the material and implements and perform all the labor measure to make the above described improvement for the following necessary to make the above described improvement for the following named prices, to-wit:

Aggregate bid based on Engineer's estimates \$1416.60.

AND WHEREAS the said D. F. McKenzie and O. L. Bowman were the lowest bidders for said proposed work and said bid was the lowest and best bid made therefor:

Section 1. That the bid of D. F. McKenzie and O. L. Bown for the improvement of Eighth Street from the west line of Calapooia That the bid of D. F. McKenzie and O. L. Bowman Street to the east line of Vine Street on the south side of the canal and Vine Street from the south line of Eighth Street Canal to the north and Vine Street from the south line of Eighth Street Canal to the north line of Ninth Street in the City of Albany, Oregon, in the manner as specified in said Ordinance No. 1787, be and the same is hereby accepted and the Mayor and Recorder of the City of Albany are hereby authorized and directed to enter into a contract in writing with the said D. F. McKenzie and O. L. Bowman for the making of said improvement on behalf of the City of Albany upon the terms mentioned in said bid hereinabove mentioned and in the manner and form provided by law.

Said contract shall provide further that the work of said improvement shall commence within ten days after the signing of said contract and shall be prosecuted with such vigor that all the work embraced in said contract shall be entirely completed on or before the thirty-first day of October, 1947 unless further time be extended by the Council of said City, and the City of Albany, Oregon, shall be deemed to suffer damages in the amount of \$25.00 per day for each and every day said work is delayed beyond said specified time, and that the said D. F. McKenzie and O. L. Bowman shall furnish a bond in the sum of \$708.30 to be approved by the Mayor of the City of Albany, Oregon, con-ditioned for the faithful performance of said contract on the part of the said D. F. McKenzie and O. L. Bowman and further indemnifying the City of Albany against any claim or lien for labor, work or material on the part of any person, firm or corporation, arising out of said contract. Said contract shall provide further that the work of said contract.
