## 4 BILR FOR:

AN ORDITIANCE to determine the probable cost of certain improvementa which the Council of the City of Albany, Oregon has determined to make in Resolution Ho. 32 adopted by sald Council on the 9th day of ApFil, 1947 to make on "hasco STMEST from the west inne of Eim Street to the east line of Umatilla Street, in the City of Albany, Oregon; to ascertain, assess, detemine and declare the proportionate share of such probable cost of suoh improvement of said Street that is assessed upon each lot or part thercof adjacent to mald part of aaid Street to be so Improved; to direot the Recopder of sald City to enter a statement of such assessment in the Doaket of City Liens as provided by the Charter of said City.

Whimezas on the 26th day of Karch, 1947 the Council of the City of Albany, oregon duly adopted a resolution requiring the city Engineer of said city to make plans and specifications for the improvement of Wasco Streat from the west ine of Elm Street to the east line of Umatilla Street, in the following manner to-wit:

1. By constructing sidewalks on the south side or said street.
2. By oonstructing concrete curbs and gutters wherever necessary.
and for the estimates of the work to be done on said portion of sald street and the probable cost there of and requiring that such plans, apeoifications, estinates and probable cost be flied in the Recorder's office of said City, said Resolution being endorsed, "Resolution No. $15^{\prime \prime}$ and adopted the a6th day of Karch, 1947.

WHEREAS the City Engineer or said City of Albany pursuant to said Resolution No. 15 made plens, specirications and estimates as difrected by the said Resolution for the 1 mprovenent of said Street in the manner specified in said Resolution No. 15 and filed said plans, apeoifioations and estimates in the Recorder's office of said City on the 9 th day of April, 1947.

HHEREAS the Council on the 9th das of April, 1947, by ResoIution No, 32 duly adopted by sald Councll, determined and resolved that it deemed it expedient and that said Council proposed to faprove Wasco Street from the west line of E1m Stroet to the east line of Umatilla Street, in the manner provided in said Resolution No. 32, and:

WHEREAS, in and by said Resolution No. 32 adopted as aforesald by the council the Reoorder of said City was duly ordered and directed by said Counoil to give notice of said proposed improvement of sald Street as provided by the Charter of said City and:

WHEREAS, the said Council in and by sald Resolution No. 32 ascertained and determinad the total probable cost of making said improvement of said Street to be paid by the owners of the real property adjacent to said portion of said street to be improved as apeciried in said Resolution No. 32 to be the sum of $\$ 2051.90$.

## THERETORE

THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLIONS:
Section 1. That Vesco Street Iram the west line of Elm
Street to the east line of Umatilila Street, in the city of Albany, Oregon be froproved as follows:

1. By constructing sidewalks on the south side of said etreet.
2. By constructing snncrete curbs and gutters wherever necessary.
all in accordance with said Resolution No. 32 and the plans and specifications for said improvement filed by the City Enginoer pif the Recorder of said aity of Albany, oregon on the 9 th day of April, 1947.

Section 2. That the probable cost of makine said improvement of sald street in the manner heretofore determined by the Council of Albany in and by Resolution No. 32 to be paid by the owners of the real property adjacent to said portion of said Street is hereby deolared to be the sum of $\$ 2051.90$.

Section 3. That the proportionate share of said probable cost of said improvement of said Street assessed upon each lot or part
