## A BILL FOR:

AN ORDINANCE declaring a deficit on account of the construction of lateral sewers in the City of Albany, Oregon as follows:

HACKIEMAN STREET LATERAL 4 - Beginning at the manhole 21 feet north of the northeast corner of Lot 1, Supplemental Plat to Block 2, Epauline Add., and running thence north through Block 3, Winona Park Addition 354 feet.

COLUMBUS STREET LATERAL 2b - Beginning at the manhole between Front and Water Streets on the west side of Columbus, and running thence easterly along the center line of Block 22, Burkhart Park Addition and along the south portion of Block 24, Burkhart Park Addition 954 feet.

by Leonard & Slate Oregon Ltd. and directing the Recorder of said City to place to the debit of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the construction of said lateral sewers, their proportionate share of such deficit.

## THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a deficit of \$130.02 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into by and between the City of Albany, Oregon and Leonard & Slate Oregon Ltd. for the construction of lateral sowers as follows:

Hackleman Street Lateral 4 - Beginning at the manhole 21 feet north of the northeast corner of Lot 1, Supplemental Plat to Block 2, Epauline Add., and running thence north through Block 3, Wincha Park Addition 354 feet.

Columbus Street Lateral 2b - Beginning at the manhole between Front and Water Streets on the west side of Columbus, and running thence easterly along the center line of Block 22, Burkhart Park Addition and along the south portion of Block 24, Burkhart Park Addition 954 feet.

in the City of Albany, Oregon, against the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the construction of said lateral sewers.

Section 2.
