ORDINANCE NO. 1899

## A BILL FOR:

AN ORDINANCE declaring a surplus of \$828.53 and a deficit in the amount of \$50.94 on account of the construction of Eighth Street Lateral No. 1 as follows:

Through the center of Lots 7, 8 and 9, St. JamesPark Addition to Albany, Oregon.

The changes as represented are these deficits and surpluses and arise from the fact that there have been some changes in ownership and the amount of work to be done as compared with the engineer's orginal estimate.

In the city of Albany, Linn County, Oregon, by D. F. McKenzie and O. L. Bowman, and directing the Recorder of said city to place the surplus to the credit of and the deficit to the debit of the various parcels of real estate improved by the construction of lateral severs heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the construction of said lateral severs, their proportionate share of such surplus or deficit.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of 3828.53 and a deficit of \$50.94 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and D. F. McKenzie and O. L. Bowman, for the construction of lateral sewers as follows:

<u>EIGHTH STREET LATER L NO. 1</u> - Through center of Lots 7, 8 and 9 in St. James Park Addition to the City of Albany, Oregon, and the surplus is in favor of, and the deficit to be charged to, the several owners of the various parcels of real estate improved by the construction of lateral severs heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column and deficit column respectively, the sums of \$828.53 and \$50.94 based upon the several amounts heretofore assessed for construction of lateral severs said surplus in favor of the various owners, and deficit to be charged to the various owners, or reputed owners of "he various parcels of real estate and in the sums as follows, to-wit:
