AN ORDINANCE declaring a surplus of \$114.00 on account of the construction of MONTGOMERY STREET LATERAL No. 1 as follows:

Beginning at the Manhole on the Montromery Street Main at the Northeast corner of Lot 9, Block 1, Bacon Addition, and running thence Westerly along the North line of said Block 1, 348 feet to the Northwest corner, Lot 3, thence South along lot lines, 50 feet.

Also, beginning at above Manhole and running Easterly along the North line of Block 1, 509 feet, thence South along lot lines 55 feet.

The changes as represented are the surpluses which arose from the fact that there have been some changes in ownership and the amount of work to be done as compared with the engineer's original estimate.

In the City of Albany, Linn County, Oregon, by D. F. McKenzie and O. L. Bowman, and directing the Recorder of said city to place the surplus to the credit of the various parcels of real estate improved by the construction of lateral severs heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the construction of said lateral severs, their proportionate share of such surplus.

Section 1. That a surplus of \$114.00 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and D. F. McKenzie and O. L. Bowman, for the construction of lateral sewers as follows:

MONTGOMERY STREET LATERAL NO. 1. - Beginning at the manhole on the Montgomery Street ain at the Northeast corner of Lot 9, Block 1, Bacon Addition, and running thence Westerly along the North Line of said Block 1, 348 feet to the Northwest corner, Lot 3, thence South along lot lines, 50 feet.

Also beginning at above manhole and running Easterly along the North line of Block 1, 509 feet, thence South along lot lines 55 feet.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column the sum of \$114.70 based upon the several amounts heretofore assessed for construction of lateral severs, said surplus in favor of the various owners in the various parcels of real estate in the sum as follows, to-wit:
