

ORDINANCE NO. 1966

A bill for:

AN ORDINANCE authorizing the Mayor and Recorder of the City of Albany, Oregon to enter into a contract with O. L. Bowman for the construction of a lateral sewer in Oak Grove Acres Addition and Tripp Addition in the City of Albany, Linn County, Oregon.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

WHEREAS, by Ordinance No. 1958 the City of Albany set out the time and manner of constructing a lateral sewer over the following described property, to-wit:

Beginning at existing manhole located at the northwest corner of Lot 1, Block 1, Oak Grove Acres Addition in the City of Albany, Linn County, Oregon, and running north 200 feet; thence northeasterly 60 feet to a point which is located 6 feet west of the northwest corner of Lot 8 of Tripp Addition of the City of Albany, Linn County, Oregon.

That said lateral sewer shall be constructed and laid in accordance with the plans, specifications and estimates of Harold Poling, City Engineer of the City of Albany, then on file in the office of said Recorder.

That it was provided by said Ordinance that the Recorder give notice for bids for making improvements, and that he did give due notice in advertisement for bids in the Albany Democrat-Herald, first publication having been made on the 12th day of February 1949, and that pursuant to said notice for bids on the 23d day of February, 1949, the time set for opening said bids, O. L. Bowman did present their bids in writing for making said improvements, which bid was in due form and conformed with all the conditions imposed by law and the Council of the City of Albany, and in such bid O. L. Bowman proposed to furnish all the material and implements and perform all the labor necessary to make the above described improvement for the following named price, to-wit:

Aggregate bid based on Engineer's estimate \$1,002.25.

That O. L. Bowman was the lowest bidder for the proposed work and said bid was the lowest and best bid made:

Section 1. That the bid of O. L. Bowman for the construction of lateral sewer beginning at existing manhole located at the northwest corner of Lot 1, Block 1, Oak Grove Acres Addition in the City of Albany, Linn County, Oregon, and running north 200 feet; thence northeasterly 69 feet to a point which is located 6 feet west of the northwest corner of Lot 8 of Tripp Addition of the City of Albany, Linn County, Oregon, be and the same is hereby accepted, and the Mayor and Recorder of said City of Albany are hereby authorized and directed to enter into a contract in writing with O. L. Bowman for the making and constructing of said lateral sewer on behalf of the City of Albany upon the terms of said specifications and bid and in the manner and form provided by law.

Said contract shall provide further that the work on said improvement shall commence within ten days after the date of the signing of the contract and shall be prosecuted with such vigor that all the work embraced in said contract shall be entirely completed on or before sixty (60) days after the date of the signing of said contract, and the said O. L. Bowman shall furnish a bond in the sum of \$501.13 to be approved by the Mayor of the City of Albany, Oregon, conditioned for the faithful performance of said contract on the part of O. L. Bowman and indemnifying the City of Albany against any claim or lien for labor, work or material on the part of any person, firm or corporation arising out of said contract.
