AM ORDINANCE DECLANING A SURFLUE AND A DEFICIT ON ACCOUNT OF THE IMPROVE-AND CALDIMANGE DECLARING A SURPLUS AND A DEFICIT ON ACCOUNT OF THE IMPROVE-MENT OF FOURTEENTH AVENUE FROM THE ELISTING PAVEMENT ON CALAFOOLA STREET EAST TO THE WEST SIDE OF HIDHWAY 99-E, AND WASHINGTON STREET FROM THE SOUTH LINE OF FOURTEENTH AVENUE SOUTH TO THE NORTH LINE OF THE PACIFIC HIGHWAY IN THE CITT OF ALBANY, LINN COUNTY, CRECON, AND DIRECTING THE RECORDER OF SAID CITY TO PLACE TO THE CREDIT OF DEBIT OF THE SEVERAL CHNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT HERETOFORE ASSESSED AND ENTERED ON THE RECORD IN THE DOCKET OF CITY LIENS OF THE CITY OF ALBANT, ORDEON FOR THEMAKING OF SAID IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS OR DEFICIT.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$1061.51 and a deficit of \$10.14 are hereby declared to exist upon the completion of the contract heretofore entered into for the improvement of Fourteenth Avenue from the existing pavement on Calapooia Street east to the west side of Highway 99-E, and Washington Street from the south line of Fourteenth Avenue south to the north line of the Pacific Highway in the City of Albany, Linn County, Oregon and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for themaking of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Lines for said City in the surplus column and deficit columns thereof, in the sum of \$1052.51 and \$10.14, respectively, based upon the several amounts heretofore assessed for making such improvement and entered therein to defray the cost of the improvement of said street, said surplus or deficit and to credit or charge the respective individuals and the parcels of real estate, and in the sums as follows, towit:
