ORDINANCE NO. 2355

AN CRAIMA I providing for the time out namer of improvement of

15th Avenue from Howard Drive to Marion

providing how the cost of such improvement shall be paid; the penalty or damage to the City of Albany by the person or persons making such improvement if the same shall not be anaplated on the time agreed upon, and the giving of a good and sufficient bons for the faithful performance of the work of such improvement, and providing for the giving by the Recorder of the said City of notice for bids for the completion of said improvement, and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DC ORDAIN AS FOLLOWS:

Section 1. That 15th Avenue from Howard Drive to Marion

be improved in the following manner, to-wit:

- Grade and gravel
 Asphalt concrete

Said improvemen shall to made in accordance with the Charter and Ordinances of the City of ban. C. agon and the plans, specifications and estimates for the improvement of id the file in the office of the Recorder of the said City of Alberry on the 2...h d " of March, 1952.

The cost of making of said improvement shall be paid out of the funds to be collected and arising upon and out of the assessments hereafter to be made, ascertained and declared by the Council of the City of ... lbany on the lote and parts of lots adjacent to said portion of said street so to be improved as hereinabove described and especially and particularly benefited thereby, as provided by the Charter of said City of Albany.

Said improvement shell be completed by the 15th day of September, 1952. The City Council reserved the right to reject any and all bids.

Any person, firm or corporation with whom any contract may be entered into by the City of albany for the making of said improvement shall, before commencing said improvement and at the time of signing such contract, make, execute and deliver to said City a good and sufficient hond with sufficient surety thereon to be approved by the Layor of the lity of Albany in a num equal to fifty per cont of the amount to be paid under such contract for the faithful performance thereof.

Section 2. If the person, firm or corporation entering into any contract with the City of Albany to make said improvement shall not complete the same within the time mentioned and specified in such contract, the City of Albany shall be demed to suffer images on account thereof in the amount of \$25.00 per day for each and every out the completion of said work is delayed beyond the time stated in such contract, which amount shall be paid by such contractor doing the work at the completion thereof, unless the time of the completion of said improvement be extended by the council.

Section 3. The descript of the City of Albany is hereby ordered and directed to immediately give proper notice for bids for making of said improvement by publishing cost section ten days in the Albany Democrat-Herald, a necespaper of general circulation published in the City of Albany, fully describing in said notice the time and section of said street.

Section 4. Imminuch as the provisions of this ordinance are necessary for the immiliate preservation of the peace, health and safety of the citizens of the City of Albery, Oregan, an emergency is hereby declared to exist and this ordinance shall be in full force and effect immediately upon its passage by the Council and its approval by the Mayor of the City of Albany.
