AN ORDINANCE ELECTING TO DISPENSE WITH AN ELECTION WITHIN THE CITY OF ALBANY UNDER SECTION 2, CHAPTER 563 OF OREGON LAWS, 1951, REGARDING ANNEXATION OF A FORTION OF HAZELWOOD ADDITION; SETTING A TIME FOR A PUBLIC HEARING ON THE SAME AND DECLARING AN EMERGENCY.

WHEREAS, on the 13th day of August, 1952, there was filed with the City Recorder of the City of Albany a petition by persons representing themselves as owners or equitable owners of property in the said Hazelwood Addition and requesting that the Council of the City of Albany elect to dispense with an election within the City of Albany concerning the annexation of a portion of Hazelwood Addition and setting a date for hearing of the same.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That an election within the City of Albany regarding the following described property to-wit:

Beginning at a point which is the southwest corner of Block 1, Albany Height's Addition, City of Albany, Linn County, Oregon; thence westerly to the southeast corner of Block 6, Hazelwood Addition, Linn County, Oregon; thence southwesterly along the northerly boundary line of the Oregon State Highway (Secondary Highway) to the place where the northern boundary line intersects the south line of Block 7, Hazelwood Addition, Linn County, Oregon; thence westerly along the south line of said Addition to the southwest corner of Block 26, Hazelwood Addition, Linn County, Oregon; thence north along the west line of Block 26 to the northwest corner of Block 28, Hazelwood Addition; thence west along the south line of Seventeenth Avenue, Hazelwood Addition, to a point which intersects the west line of Block 31, Hazelwood Addition, if extended southerly; thence northerly to the northwest corner of Block 31, Hazelwood Addition; thence northerly along the west boundary line of Marion Street, Hazelwood Addition, to a point which is the intersection of the south line of Fifteenth Avenue and the west line of Marion Street, Hazelwood Addition; thence easterly along the north line of Blocks 30 and 25 to the northwest corner of Block 24 to the northwest corner of Block 24, Hazelwood Addition; thence easterly along the north line of Block 24, Hazelwood Addition; to the northwest corner of Block 17 of said addition; thence northerly along the east boundary line of Hop Street to a noint which is the intersection of the asst line of Hop Street and the south boundary line of Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon; thence easterly along the south line of Block 1, Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon; thence easterly along the south line of Block 1, Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon; thence easterly along the south line of Block 1, Sprenger's Supplemental Plat to Hazelwood Addition, Linn County, Oregon; thence easterly along the sout

shall be and is hereby dispensed with pursuant to and under the terms of Section 2 of Chapter 563 of Oregon Laws, 1951.

Section 2. That there shall be held a public hearing as to the advisability of annexing that portion of Hazelwood Addition described in Section 1 to the City of Albany on the 24th day of September, 1952, and at 7:00 P.M., the City Recorder of the City of Albany is hereby directed to give notice of the said public hearing by publishing in a newspaper of general circulation once a week for two successive weeks and by posting in four public places a notice setting forth the time and place of the said hearing the description of the property to be considered for annexation and the purpose for which the hearing is held.
