## CRDINANCE NO. 2419

AN ORDINANCE ESTABLISHING LOG TRUCK ROUTES WITHIN THE CITY OF ALBANY, DEFINING A PENALTY FOR VIOLATION THEREOF AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS POLLOWS:

Section 1: The following streets and public ways within the City of Albany shall be and hereby are designated as log truck routes:

Highway 99 5 from southern city limits to northern city limits.

Highway 20 from east city limits to Hiway 99 E.

Gid Pacific Hiway from east city limits to Davidson Street.

Davidson street from old Pacific Hiway to Front Avenue.

Front Avenue from Davidson atreet to Fulton street.

Fulton street from Front Avenue to Northern city limits.

Main street from Hiway 99E to Water Avenue.

Water Avenue from Main Street to Madison Street.

Madison Street from Water Avenue to the river.

Sixth Avenue from Main Street to Pine Street.

Lyon Street from Hiway 99 E to Water Avenue.

Water Avenue from Lyon Street to Washington Street.

Washington Street from Water Avenue to River.

First Avenue from Lyon Street to Jefferson Street.

Montgomery Street from First Avenue to River.

Jefferson Street from 1st Avenue to River.

Elisworth Street from Hiway 99 E to North city limits.

Queen Avenua from west city limits to Marion street.

Marion street to Jackson at Thirteenth, thence to Hiway 99 E.

Howard Drive from Oueen Avenue to 12th Avenue.

Ninth Avenue from Thurston Street to Jackson Street and from Madison street to Lafayette Street.

Ninth Avenue from Ellsworth to Lyon Madison street from 9th Avenue to Hiway 99 E.

Section 2: It shall be a violation of this ordinance for any loaded log trucks, including piling trucks, regardless of whether they are single or tandem sxel or truck and trailer combinations, to travel, loaded, upon any other street or thoroughfare within the City of Albany other than upon the streets and public ways as above set forth in Section 1.

Section 3: Any violation of this ordinance, upon conviction thereof in the Recorder's Court of the City of Albany, shall be fined not less than \$5.00 nor more than \$100.00.

Section 4: Whereas the foregoing ordinance is necessary to the peace, health and safety of the citizens of the City of Albany in that travel by loaded log trucks on other than the above designated streets will seriously damage the surface thereof, an emergency is hereby declared and this ordinance shall be in full force and effect upon passage by the council and a igning by the mayor.
