ORDINANCE NO. 2540

AN ORDINANCE PROVIDING FOR THE TIME AND MANNER OF IMPROVEMENT OF 14TH AVENUE FROM THE WEST LINE OF OAK DRIVE TO THE WEST LINE OF SHERMAN STREET MORE PARTICULARLY DESCRIBED IN RESOLUTION NO. 284; PROVIDING HOW THE COST OF THE IMPROVEMENT SHALL BE PAID; AUTHORIZING THE MAYOR AND CITY MANAGER TO ENTER INTO A CONTRACT WITH WARREN-NORTHWEST, INC., FOR THE CONSTRUCTION OF SAID IMPROVEMENT UNDER THE SUPERVISION OF THE CITY ENGINEER: AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That 14th Avenue from the West line of Oak Drive to the West line of Sherman Street be improved in the following manner, to-wit;

Grade and Gravel
Curb and Gutter
Suitable hard surfacing

Said improvement shall be made in accordance with the charter and ordinances of the City of Albany, Oregon, and the plans and specifications and estimates for the improvement of the said street filed in the office of the Recorder of the City of Albany on the 28th day of July, 1954.

Section 2: The cost of making said improvements shall be paid out of the assessments hereinafter to be made, ascertained and declared by the Council of the City of Albany on the lots and parts of lots adjacent to said portion of the said street so to be improved as hereinabove described and especially and particularly benefited thereby as provided by the charter of the City of Albany, Oregon.

Section 3: That by reason of the type and amount of the said improvement, the council specifically finds that it would be unreasonable to advertise the same for bids and authorizes the May or and City Manager to enter into a contract with the Warren-Northwest, Inc., underthe same terms and conditions of the contract authorized in Ordinance N. 2531, Ordinances of the City of Albany, Oregon, and under the same unit prices for work upon streets of a similar nature as therein set forth, not to exceed the sum of \$1,355.04, said improvement to be according to the plans and specifications hereinabove mentioned.

Section 4: Inasmuch as the provisions of this ordinance are necessary for the immediate preservation of the peace, health and safety of the citizens of the City of Albany, Oregon, to provide for the completion of the above improvement during the 1954 street improvement program, an emergency is hereby declared to exist and this ordinance shall be in full force and effect immediately upon its passage by the council and its approval by the Mayor of the City of Albany.
