AN ORDINANCE PROVIDING FOR THE DATE AND MANNER FOR HOLDING A SPECIAL ELECTION IN A PORTION OF HAZELWOOD ADDITION TO THE CITY OF ALBANY ON THE 2ND DAY OF NOVEMBER, 1954, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE SAID TERRITORY FOR THEIR ADOPTION OR REJECTION A PROPOSAL TO ANNEX THE SAID FORTION OF HAZELWOOD ADDITION TO THE CITY OF ALBANY, OREGON, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY, OREGON DO ORDAIN AS FOLLOWS:

Section 1: That in a manner provided by law and in this ordinance for the purpose set forth herein, a special election will be held on a portion of Hazelwood Addition to the City of Albany, Linn County, Oregon, as below described on the 2nd day of November, 1954, commencing at the hour of 8:00 o'clock A.M. on said day, PST.

Section 2: The following is hereby designated as the voting place of the said election, the same being the regular voting place for the general election held upon the same day as the special election: V. W. Mason residence, 820 Broadway Street, Albany, Oregon.

Section 3: The judges and clerks of the said special election who shall supervise the election within the below described territory shall be the same as those designated by the Linn County Court for the general election for the year of 1954 for the Calapooia district.

Section 4: The City Recorder shall cause notice of the said special election to be given by publication thereof in a newspaper of general circulation within said city once a week for four (4) consecutive weeks, the first date of publication to be the 5th day of October, 1954, and the said notice shall state the time, voting place and description of the territory proposed to be annexed.

That the City Recorder, in addition to the notice required in Section 5: Section Four shall cause to be posted in four (4) conspicuous places within the territory proposed to be annexed on or before October 5, 1954, notices of special election to be in the following form:

Notice is hereby given that on November 2, 1954, at the V. W. Mason residence, 820 Broadway Street, Albany, Oregon, in the Calapoola precinct, in the Hazelwood Addition to the City of Albany, Oregon, a special election will be held concerning the proposed annexation of the following described territory of the City of Albany:

Beginning at a point which is the Southwest corner of Block 1, Albany Heights Addition to the City of Albany, Linn County, Oregon;

thence Westerly to the Southeast corner of Lot 2, Block 6,

Hazelwood Addition, Linn County, Oregon; thence Southwesterly along the South line of Block 6, Hazel-wood Addition and continuing on the same course to a point on the South line of Lot 3, Block 7, Hazelwood Addition, said point being the most Southerly Southeast corner of Hazelwood Addition; thence Westerly along the South line of Hazelwood Addition to the Southwest corner of Lot 5, Block 28, Hazelwood

thence Northerly along the East line of Marion Street to the Northwest corner of Lot 4, Block 30, Hazelwood Addition:

thence Easterly along the South line of Fifteenth Avenue to the Northwest corner of Lot 4, Block 18, Hazel-wood Addition;

thence Northerly along the East line of Hop Street to the Northwest corner of Lot 8, Block 14, Hazelwood Addition;

thence Easterly along the North line of Block 14, Hazel-wood Addition and continuing Easterly on the same course to the Northwest corner of Lot 8, Block 13, Hazelwood Addition;

thence Northerly along the Fast line of Gail Street ex-tended Northerly to intersect the South line of the

Masonic Cemetery property; thence Westerly along the South line of the Masonic Cemetery property to the Southwest corner of said thence Northerly along the West line of the Masonic Cemetery to the South railroad right-of-way of the Oregon Electric

Railroad; thence Easterly along the South railroad right-of-way line of Oregon Electric Railroad to the West line of Umatilla Street and continuing Easterly on the same course to the East line of UmatillaStreet;

thence Southerly along the gast line of Umatilla Street to the South line of Seventh Avenue; thence Westerly along the South line of Seventh Avenue to the East line of Broadway Street;

thence Southerly along the East line of Broadway Street to the point of beginning.

which election will be held at 8:00 o'clock in the morning and will continue until 8:00 o'clock in the afternoon, Pacific Standard Time, of said day.

Registered voters in the said territory are invited to vote upon the proposed annexation.

Hazelwood Addition, Linn County, Oregon; thence Southwesterly along the South line of Block 6, Hazelwood Addition and continuing on the same course to a point on the South line of Lot 3, Block 7, Hazelwood Addition, said point being the most Southerly Southeast corner of Hazelwood Addition;

thence Westerly along the South line of Hazelwood Addition to the Southwest corner of Lot 5, Block 28, Hazelwood Addition;

thence Northerly along the West line of said Lot 5

to the Northwest corner thereof; thence Easterly along the North line of Lot 5, Block 28, Hazelwood Addition to a point which intersects the East line of Block 31, Hazel-

wood Addition if extended Southerly; thence Northerly along said extended line to the Southeast corner of Lot 8, Block 31, Hazelwood

Addition; thence Easterly along the North line of Seventeenth Avenue to the Southwest corner of Lot 5, Block

East line of Umatilla Street;
thence Southerly along the East line of Umatilla Street
to the South line of Seventh Avenue;
thence Westerly along the South line of Seventh Avenue
to the East line of Broadway Street;

to the East line of Broadway Street; thence Southerly along the East line of Broadway Street to the point of beginning.

Section 8: Inasmuch as the special and the dates of holding the same must, for the convenience, peace, health and safety of the citizens of the City of Albany and the said territory to be annexed be held on the date aforesaid, an emergency is hereby declared and this ordinance shall be in full force and effect immediately upon its passage by the council and approval by the Mayor.
