ORDINANCE NO. 2621

AN ORDINANCE ANNEXING A PORTION OF PROPERTY ADJACENT TO THE SOUTHERLY CITY LIMITS OF ALBANY, LINN COUNTY, OREGON.

WHEREAS, on the 9th day of November, 1955, at a regular council meeting, the council of the City of Albany, Oregon, did duly pass Ordinance No. 2617, wherein it was provided that a public hearing would be held on the 14th day of December, 1955, concerning advisability of annexation of a portion of property adjacent to the Southerly City Limits of Albany, Linn County, Oregon, and,

WHEREAS, the hearing was duly held on the 14th day of December, 1955, and, at that time, the council determined that the notices of the hearing had been duly given as provided in said ordinances and pursuant to the terms of 222,120 O.H.S., and

WHEREAS, the Council, after said hearing, determined that the said portion of the property adjacent to the Southerly City Limits of Albany, Linn County, Oregon, be annexed to the City of Albany, Oregon, and the consent of property owners have been filed giving their consent for the said annexation.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

<u>Section 1</u>: That the following described property be and it is hereby annexed to the City of Albany, Oregon, to-wit:

Beginning at the Southeast corner of the George Cline D.L.C. #84 in T. Il S., R. 4 W. of the Will. Mer. in Linn County, Oregon; and running thence S. 89 deg 42' E. 8.50 feet to the Northeast corner of Fir Oaks Addition Revised to the City of Albany, Linn County, Oregon; thence S. 14 deg 12' E. 198.19 feet to the Southeast corner of Tract 31 of said Addition; thence S. 89 deg 42' East, parallel with the South line of said Claim #84 (if extended Easterly) to the East right-of-way line of the Pacific Highway; thence Southerly along said right-of-way line to a point N. O deg 54½' W. 1711.04 feet and N. 88 deg 54½' E. 66.0 feet from the NW corner of the Truett Davis D.L.C. #38 in said township and Range; thence N. 88 deg. 54½' E. 400.0 feet; thence S. O deg. 54½' E. 283.0 feet; thence S. 88 deg 54½' W. 40.0 feet; thence S. O deg. 54½' E. 283.0 feet; thence N. 88 deg 54½' E. to the West right-of-way line of the Southern Pacific Railroad; thence N. O deg 02' W. along said right-of-way 1095.5 feet to a point 50.0 feet South of the South line of South Albany Addition; thence S. 89 deg 00' W., parallel to the South line of said South Albany Addition, to the West right-of-way of the aforementioned Pacific Highway; thence Northerly along said Highway to the South line of Houck's Addition to the City of Albany; thence Westerly to the Southwest corner of said Houck's Addition; thence Northerly to the Northwest corner of said Houck's Addition; thence Westerly, along the Westerly extension of the North line of said Houck's Addition, to the East line of the aforementioned George Cline D.L.C. thence Southerly along said East line to the place of beginning, excepting therefrom that part lying within the right-of-way of the Pacific Highway.
