## ORDINANCE NO. 2638

AN ORDINANCE VACATING PORTIONS OF SOUTH DIVISION STREET, NORTH DIVISION STREET, COX STREET, IDLEWILD STREET, AND CAKWOOD STREET.

WHEREAS, the Council of the City of Albany did, by Resolution No. 354 at the Council Meeting on December 30, 1955, set the hour of 7:15 PM on February 8, 1956, as the time for hearing objections to the proposed vacation of that portion of South Division Street, North Division Street, Cox Street, Idlewild Street, and Oakwood Street, all located in Glendorr Tracts in Linn County, State of Oregon, that lies within the corporate limits of the City of Albany, Linn County, Oregon, said portions being more particularly described in said Resolution and did direct, by said resolution, that notice be posted and published as required by law, and

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

The following portions of South Division Street, North Division Street, Cox Street, Idlewild Street, and Cakwood Street, all located in Glendorr Tracts in Linn County, State of Oregon, that lies within the corporate limits of the City of Albany, Linn County, Oregon, more particularly described as follows:

- 1. All of South Division Street lying within the corporate limits of the City of Albany, Linn County, Oregon, with terminus from the West boundary line to the East boundary line of the corporate limits of the City of Albany, Linn County, Oregon.
- 2. All of North Division Street lying within the corporate limits of the City of Albany, Linn County, Oregon, with terminus from Idlewild Street to the East boundary line of the corporate limits of the City of Albany, Linn County, Oregon.
- 3. All of Cox Street lying with/the corporate limits of the City of Albany, Linn County, Oregon, with terminus from Idlewild Street to the East boundary line of the corporate limits of the City of Albany, Linn County, Oregon.
- 4. All of Oakwood Street lying within the corporate limits of the City of Albany, Linn County, Oregon, with terminus from Idlevild Street to the East boundary line of the corporate limits of the City of Albany, Linn County, Oregon.
- 5. All if Idlewild Street all in the corporate limits of the City of Albany, Linn County, Oregon.
