ORDINANCE NO. 2707

AN ORDINANCE TO AMEND ORDINANCE NO. 2702, A PORTION OF SECTION 2, THEREOF. AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That portion of Section 2 of Ordinance No. 2702 which reads as follows: "E. B. Hagedorn, Lot 2, Block 19, Hazelwood Addition - \$142.68," be amended to read as follows:

E. B. Hagedorn - All of Lot 2, except the West 11 feet thereof of Block 19, Hazelwood Addition - \$111.29

Amos Hiester, West 11 feet of Lot 2, Block 19, Hazelwood Addition - \$31.39

Section 2: That portion of Section 2 of Ordinance No. 2702 which reads as follows: "C. C. Henshaw, Lot 6, Block 15, Hazelwood Addition - \$142.68", Robert C. Addington, Lot 5, Block 15, Hazelwood Addition - \$142.68", be amended to read as follows:

C. C. Henshaw, all of Lot 6 except the West 15 feet thereof of Block 15, Hazelwood Addition - \$99.88

Robert C. Addington Lot 5 and West 15' of Lot 6, Block 15, Hazelwood Addition \$185.48

Section 3: That portion of Section 2 of Ordinance 2702 which reads as follows:
"Malcom Phillips Lot 4, Block 7, part, Hazelwood Addition - \$75.34;"
Malcom Phillips Lot 5, Block 7, Part, Hazelwood Addition - \$71.34;"
"William F. & Lillian Merrill, Lot 4, Block 7 part, Hazelwood Addition - \$159.81;"
"William F. & Lillian Merrill, part of Lot 5, Block 7, Hazelwood Add. - \$142.68;"
be amended to read as follows:

William F. & Lillian Merrill, Lot 4, Block 7, Hazelword Addition - \$235.15

William F. & Lillian Merrill, Lot 5, Block 7, Hazelwood Addition - \$214.02

Section 4: That the Recorder of the City of Albany, Oregon, is hereby ordered and directed to immediately enter a statement of the assessment made and declared by this Ordinance together with the names of the respective owners of such lots or parts thereof herein above described in the docket of City Liens of said City of Albany, Oregon, as provided in the Charter of said City and to give notice thereof as provided by law.

Section 5: Inasmuch as the provisions of this Ordinance are necessary for the Immediate preservation of the peace, health and safety of the citizens of Albany, Oregon, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately upon its passage by the Council and its approval by the Mayor.
