RECITALS:

WHEREAS, the Parks and Recreation services provided by the City of Albany do not have sufficient funds to adequately carry out the program in the best interest of the citizens, and

WHEREAS, the Parks and Recreational program require capital improvement which cannot be financed from the present revenue received by the City of Albany,

WHEREAS, it is necessary that a Special Election be held within the City and of Albany authorizing the City Council to levy taxes outside the 6% limitation for realization of additional funds to maintain an adequate Park and Recreational program, now, therefore,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That a Special Election by the legal voters of the City of Albany, Linn County, Oregon, shall be held on the 10th day of June, 1957, beginning at the hour of 8:00 o'clock a.m. and continuing until the hour of 8:00 o'clock p.m. of the said day for the purpose of submitting to the qualified and legal voters of the said City, a proposition, if adopted, which will authorize the Council of the City of Albany to levy annually, beginning July 1, 1957, and continuing for a period of ten (10) years, a special City Tax Levy of \$40,000.00 per year to provide for the management and operation of Civic, Recreational and Community activities; the said levy shall be outside the 6% limitation imposed by Section 2, Article XI of

Section 2: The City Recorder shall give at least ten (10) days notice of the Oregon Constitution. this Special Election by posting notice thereof in a conspicuous place in the City Hall and have not less than two (2) publications in a newspaper of general circulation published in the City of Albany, Oregon. The notice as given shall include

the following ballot title to be voted upon:

"SPECIAL TAX LEVY FOR CIVIC, RECREATIONAL AND COMMUNITY ACTIVITIES"

An act to authorize the City Council of the City of Albany, Oregon, to provide for a Special Continuing Tax Levy of \$40,000.00 per year for a period of 10 years out-side the 6% tax limitation imposed by Section 2, Article XI of the Oregon Constitution to be used for Civic, Recreational and Community activities, the said levy

to begin 1957-1958.

Section 4: The peace, health, and safety of the citizens of the City of Albany require that this Ordinance become immediately effective, therefore, an emergency is declared to exist and this Ordinance shall become immediately effective upon final passage by the Council and approval by the Mayor.
