## RECITALS:

1. Heretofore the council has assessed certain property in Morningside Tracts and Southern Addition to Morningside Tracts for certain street and sewer improve-ments as described in Ordinance No. 2755, 2756 and 2761.

2. Subsequent to the assessments, the owners thereof the property therein have requested the Council to segregate the liens against the said property in a manner that the property can be sold in smaller parcels than originally platted, making the same more desirable as home sites and more desirable for a subdivision.

Section 2: Nothing in this ordinance shall be in any way considered as altering the lien dates as established in the previous ordinances, the purpose of this ordinance being only to amend the description of the property benefited by a specific lien and the amount of the lien.

Section 3: The City Recorder is instructed to make the necessary changes on the lien dockets of the City to carry out the purpose of this ordinance and to effect the amend-ments as above provided.

Section 4: Inasmuch as expediency is desired to provide for the proper disposal and sale of the property, thereby benefiting the people of the City by allowing the said liens to be promptly paid, and the same being to the benefit of the general peace, health, safety and welfare of the City of Albany, an emergency is hereby declared to exist and this ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
