# ORDINANCE NO. 2834

AN ORDINANCE AMENDING SECTIONS 23 AND 24 OF ORDINANCE NO. 2751, RELATING TO PARKING METER HOODS AND THEIR USE AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS;

Section 1: Section 23 and Section 24 of Ordinance No. 2751 is hereby amended to read as follows:

"Section 23: PARKING METER HOODS

Parking Meter Hoods may be issued by the Chief of Police for the following purposes:

- a) For the use of persons engaged in construction or repair of a building or the installation of equipment therein. Such hoods shall be issued only where an unmetered area is not reasonably close to the place where such persons are engaged. An initial fee of \$1.00 shall be paid for each hood issued with an additional fee of \$3.00 for each week of use.
- b) For the use of persons in charge of buildings that are used for public gatherings. The hoods shall be to provide Loading Zones in front of such buildings when it promotes safety. Any such persons requesting a meter hood under this subsection shall pay a deposit of \$1.00 to be refunded upon return of the hood.

## Section 24: USE OF PARKING METER HOODS

Persons with a properly issued hood shall have the privilege of placing the same upon Parking Meters reasonably close to the place where they are engaged or the public gathering is being held, thereby reserving such parking meter space while occupied for use or while the gathering place is being used by the public."

### Section 21

Whereas it is necessary for the immediate preservation of the public health, peace and safety of the citizens of the City of Albany that this Ordinance become effective at the earliest possible time, therefore, this Ordinance shall become effective immediately upon its passage by the Council and approval of the Mayor.

CRDINANCE NO. 2834 A

AN ORDINANCE TO AMEND ORDINANCE NO. 2413 BY ADDING SECTION VII (a) BY PROVIDING FOR AUTHORITY FOR STATE INSPECTION AND AUTHORIZING CONTRACT WITH THE STATE OF OREGON FOR INSPECTION OF ELECTRICAL INSTALLATION, AS REQUIRED IN THIS ORDINANCE, PROVIDING THAT THE STATE ELECTRICAL INSPECTION SHALL BE IN LIEU OF ANY INSPECTION FEES AND REQUIREMENTS FOR INSPECTION BY THE CITY ELECTRICAL INSPECTOR, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

### Section 1: ADDITION OF SECTION

Ordinance No. 2413 is hereby amended by the addition of Section VII(a) as

followst

"Section VII (a): AUTHORITY FOR STATE INSPECTION. The City Manager, with the approval of the City Council, shall have authority to enter into any contract with the State of Oregon for electrical inspection, as required in this Ordinance. This section is permissive in nature and it is not necessarily required that the City enter into a contract with the State of Oregon for the furnishing of electrical inspection service by the State of Oregon to the City of Albany. Fees for inspection services provided by the State of Oregon shall be determined by the State and collected by them and shall be in lieu of any fees required for any City inspection, permits or otherwise. Any inspection of electrical facilities by a State Electrical Inspector shall be in lieu of all inspections required under this Ordinance by the City Electrical Inspector."

#### Section 2: EMERGENCY CLAUSE

Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the citizens of the City of Albany, an emergency is hereby declared to exist and it shall be effective upon its passage by the Council and approval by the Mayor.
