## ORDINANCE NO. 2836

AN ORDINANCE PROVIDING FOR THE DATE AND MANNER OF HOLDING A SPECIAL ELECTION IN THE CITY OF ALBANY, OREGON, ON THE 30TH DAY OF MARCH, 1959, FOR THE PURPUSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF ALBANY THE FOLLOWING: (1) A SPECIAL LEVY, \$2,700.00 FOR REFAIRS OF THE SWIMMING POOL, THE LEVY TO BE OUTSIDE OF THE 6% LIMITATION; (2) A SPECIAL CONTINUING FIVE YEAR LEVY OF \$4,200.00 A YEAR OUTSIDE THE 6% LIMITATION, SAID MONEY TO BE USED FOR MOSQUITO CONTROL; (3), A SPECIAL CONTINUING TEN YEAR LEVY OF \$20,000.00 FOR THE 6% LIMITATION TO USE FOR PARKS AND RECREATION PURPUSE; (4) A SPECIAL LEVY OF \$10,000.00 FOR TRAFFIC SIGNALS, LEVY TO BE OUTSIDE OF 6% LIMITATION, SAID MEASURES TO BE SUBMITTED FOR VOTER'S ADOPTION OR REJECTION AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DU CHDAIN AS FOLLOWS:

## Section 1: TIME AND MANNER OF ELECTION

In a manner provided by law and in this Ordinance, and for the purposes set forth herein, a Special Election shall be held in the City of Albany, Oregon, on the 30th day of March, 1959, commencing thereon at 8:00 a.m. of said day and continuing until 8:00 p.m. of said day.

## Section 2: VOTING PLACES

The following are hereby designated as voting places for said election:

First Ward: Maple School Second Ward: Central School Third Ward: Madison School

## Section 3: JUDGES AND CLERKS

The Judges and Clerks of the Special Election to supervise the election in each of the within wards of the City of Albany shall be as follows:

#### First Ward:

#### Second Ward:

#### Third Ward:

#### Section 4: CATH

The Judge and the Clerks shall qualify by subscribing to an Oath in the manner and form provided by law and in case any such officers shall fail to attend, then those present shall elect another to act in his place.

## Section 5: NOTICE OF SPECIAL ELECTION

The City Recorder shall cause Notice of said Special Election to be given by publication thereof in a newspaper of general circulation published in the City of Mibany at least once a week for two (2) successive weeks; the first publication shall be within fifteen (15) days next proceeding the date of the Special Election. Said

Notice shall state the time, voting places and a statement of the substance of the matters to be voted upon.

# Section 6: POSTING OF NOTICE

The City Recorder, in addition to the Notice required in Section 5, shall cause to be posted in ten (10) conspicuous places within each of the three Wards, at least ten (10) days before the date of the Special Election, Notice of the Special Election in the following form:

#### "SPECIAL. ELECTION NOTICE"

NOTICE IS HEREBY GIVEN that on the 30th day of March, 1959, at (location) in the Ward in the City of Albany, Oregon, a Special Election will be held referring to the people of the City of Albany for their adoption or rejection, the following Special Tax Matters:

- A Special Tax Levy for repairs to the swimming pool. An act to provide for a Special Tax Levy of \$2,700.00 outside the 6% Tax Limitation for the tax year 1959-60 to be used for the repair of the Albany Swimming Pool.
- 2) A Special Tax Levy for Mosquito Control. An act to provide for a Special Continuing five year levy of \$4,200.00 per year outside the 6% Tax Limitation beginning 1959-60 for the use of Mosquito Control within the City of Albany.
- 3) A Special Tax Levy for Parks and Recreation.
  An act to provide for the Special Continuing
  Ten Year Tax Levy of \$20,000.00 per year
  outside the 6% Tax Limitation, beginning
  1959-60, said monies to be used for Parks
  and Recreation purposes within the City of
  Albany.
- 4) A Special Tax Levy for Traffic Signals at Pacific Blvd. and Highway 20. An act to provide for a Special Tax Levy of \$10,000.00 outside the 6% Tax Limitation for the tax year 1959-60 to be used for Traffic Signals at Pacific Blvd. and Highway 20.

Such election to be held at 8:00 o'clock a.m. in the morning and will continue until 8:00 o'clock p.m. in the evening of said day.

## Section 7: REJECTION OR ADOPTION OF MEASURE

At the said Special Election, there shall be submitted to the legal voters of the City of Albany for their adoption or rejection those measures as hereinafter set forth in Section 9.

## Section 8: INFORMATION SHEETS

The Recorder shall cause to be printed, a true copy of the title and text of the matters to be submitted to be voted upon, together with the number and form on which the same will appear on the Official Special Election Ballot and shall mail one of each information sheets to each registered voter in the City of Albany not later than five (5) days before the date of the Special Election and preceding the copy of the

matters to be voted upon as herein set forth, there shall be a statement that the same will be voted upon at a Special Election to be held on the 30th day of March, 1959, between the hours of 8:00 a.m. and 8:00 p.m.

# Section 9: TITLE OF MEASURES

The ballot titles of the matters submitted to the voters shall be as follows:

- Measure No. 10 SPECIAL TAX LEVY FOR SWIMMING POOL REPAIR AN ACT to provide for a Special Levy of \$2,700.00 outside the 6% Tax Limitation for the year 1959-60 for repair of the Albany Swimming Pool.

  - Measure No. 20 SPECIAL TAX LEVY FOR MOSQUITO CONTROL AN ACT to provide for Special Continuing five years Tax Levy of \$4,200.00 per year outside the 6% Tax Limitation beginning in 1959-60, for the use of Mosquito Control within the City of Albany.
    - TYES NO
- Measure No. 30 SPECIAL TAX LEVY FOR PARKS AND RECREATION AN ACT so as to provide a Special Continuing Ten Year Tax Levy of \$20,000.00 per year outside the 6% Tax Limitation beginning 1959-60 to be used for Parks and Recreation purposes within the City of Albany.

- Measure No. 40 SPECIAL TAX LEVY FOR TRAFFIC CONTROL SIGNALS AN ACT to provide for a Special Levy of \$10,000.00 outside the 6% Tax Limitation for the year 1959-60 to be used for Traffic Control Signals at the intersection of Pacific Blvd. and Highway 20.
