

ORDINANCE NO. 2841

AN ORDINANCE AMENDING ORDINANCE NUMBERS 2755 AND 2820 FOR THE PURPOSE OF SEGREGATING CERTAIN LIENS IN THE CITY OF ALBANY, OREGON.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:
