AN ORDINANCE RELATING TO DISPENSING WITH AN ELECTION WITHIN THE CITY OF ALBANY, OREGON, UNDER 222,120 ORS REGARDING THE ANNEXATION OF CERTAIN PROPERTY LYING EAST OF 2ND ADDI-TION TO VISTA HOMES, LINN COUNTY, OREGON, AND A PORTION OF BLOCK 3, KURRE LAKESIDE TRACTS, AND A PORTION ADJACENT THERETO.

WHEREAS, on the 7th day of May, 1959, there was filed with the City Recorder of the City of Albany, a petition and consent by the Fetitioner, Guy M. Aupperle representing to be the owner of property contiguous to the City of Albany, Oregon, to elect to dispense with an election within the City of Albany concerning the annexation of said property and setting a date for the hearing of the same.

WHEREAS, on the 13th day of May, 1959, there was filed with the City Recorder of the City of Albany, a petition and consent by the Fetitioners, Harold and Helen W. Wood, Mr. & Mrs. G. P. Missen, John D. Stokes, harriet E. and E. L. Gregerson, Louise Straney and Gene Straney, representing to be the owners of property contiguous to the City of Albany, Oregon, to elect to dispense with an election within the City of Albany concerning the annexation of said property and setting a date for the hearing of the same.

THE PLOPLE OF THE CITY OF ALBANY DO CRDAIN AS FOLLOWS:

Section 1: DESCRIPTION OF PROPERTY

That an election within the City of Albany regarding the annexation of the following described property to-wit:

Beginning at the S.E. corner of Tract 32 of 2nd Addition to Vista Homes in Linn County, Oregon, thence N. 0°56' W. 772.63' to the N.E. corner of Tract 25 of said 2nd Addition to Vista Homes, thence S. 86038' E. 820' more or less to the W. line of a public road known as Ermine Street, thence Southerly 722' along the W. line of Ermine Street, thence Easterly along the N. line of 34th Avenue 837.42' to the place of beginning,

be dispensed with.

Whereas, it is in the betterment of the public health, interest, aafety and general welfare of the citizens of the City of Albany that this matter of annexation of the property described herein be disposed of at the earliest possible moment, and should the same be annexed, that the City facilities be made available to this property, therefore, an emergency is hereby declared to exist and this Ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
