AN ORDINANCE PROVIDING FOR THE DATE AND MANNER OF HOLDING A SPECIAL ELECTION IN AREA NO.1,
LINIGH ADDITION AND ADJACENT AREA ON THE 18TH DAY OF DECEMBER, 1959, FOR THE PURPOSE OF SUBMITTING
TO THE LEGAL VOTERS OF THE SAID TERRITORY FOR THEIR ADOPTION OR REJECTION A PROPOSAL TO ANNEX
GAID AREA NO.1, LEHIGH ADDITION AND ADJACENT AREA TO THE CITY OF ALBANY, OREGON, AND DECLARING
AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DAY AND TIME FOR RESCTION

That in a manner provided by law and in this Ordinance and for the purpose set forth herein, a special election shall be held in Area No. 1, Lehigh Addition and adjacent area, Linn County, Oregon, as below described on the 18th day of December, 1959, commencing at the hour of 8 o'clock a.m. on the said day, Pacific Standard Time.

Section 2: VOTING PLACE

That the following is hereby designated as the voting place of the said election: Eastside Christian Church, 2750 Santiam Highway, Albany, Oregon.

Section 3: JUDGE AND CLERKS

That the Judge and Clerks of the said special election who shall supervise the election within the below described territory, shall be:

Mrs. Minerva Black, Judge Mrs. Jane Kyle, Clerk Mrs. Georgeanna Riley, Clerk

Section 4: NOTICE

The City Recorder shall cause notice of the said special election to be given by publication thereof in a newspaper of general circulation within the city once a week for four (4) consecutive weeks, first date of publication to be the 20th day of November, 1959, and said notice shall state the time, voting place and a description of the territory proposed to be annexed.

Section 5: FOSTED NOTICES

The Recorder, in addition to the notice required in Section 4 above, shall cause to be posted in four (4) conspicuous places within the territory proposed to be annexed at least ten (10) days before the date of the special election, notices of the special election in the following form:

"SPECIAL ELECTION NOTICE"

NOTICE IS HEREBY GIVEN that on the 18th day of December, 1959, at Eastside Christian Church, 2750 Santiam Highway, Albany, Oregon, a special election will be held concerning the proposed annexation of the following described territory to the City of Albany, to-wit:

Beginning at a point on the present city limits line, said point being the intersection of the N. line of Queen Ave. and the W. line of Oak St.; thence Easterly along the N. line of Queen Ave. extended to Geary St.; thence Easterly along the N. line of county road to Waverly Drive; thence Northeasterly to the S.W. corner of that property described in Book 250, Page 331 of Linn County Deed Records; thence Easterly along the S. property line of said property and along the S. boundary of that property described in Book 237, Page 28, Linn County Deed Records, to the State Hwy. right-of-way; thence Northerly to a point on the city boundary line, which point is the intersection of the S. margin of Franklin and the W. margin of Airport Rd.; thence Westerly; thence Southerly; thence Westerly; thence Northerly; thence Westerly; thence Northerly; thence Westerly; thence Northerly; thence Westerly; all along present city limits line, to Waverly Drive; thence along present city limits line to a point of beginning.

Registered voters in said territory are invited to vote upon the proposed annexation.

Section 6: PURPOSE OF ELECTION

At the said special election, the proposed annexation of the territory described below shall be submitted to the legal voters of the said territory for their adoption or rejection as hereinafter set forth in Section 7.

Section 7: SAMPLE BALLOT

The ballot title of the proposed annexation submitted to the registered voters of the said territory shall be as follows:

"PROPOSAL TO ANNEX AREA NO. 1, LEHIGH ADDITION AND ADJACENT TERRITORY, LINN COUNTY, OREGON."

AN ACT to annex the following described territory to the City of Albany:

Beginning at a point on the present city limits line, said point being the intersection of the N. line of Queen Ave. and the W. line of Oak St.; thence Easterly along the N. line of Queen Ave. extended to Geary St.; thence Easterly along the N. line of county road to Waverly Drive; thence NEly to the S.W. corner of that property described in Book 250, Page 331 of Linn County Deed Records; thence Easterly along the S. property line of said property and along the S. boundary of that property described in Book 237, Page 28, Linn County Deed Records, to the State Hwy. right-of-way; thence Northerly to a point on the city boundary line, which point is the intersection of the S. margin of Franklin and the W. margin of Airport Rd.; thence Westerly; thence Southerly; thence Westerly; thence Southerly; thence Westerly; thence Northerly; thence Westerly; thence Northerly; thence Westerly all along present city limits—line, to Waverly Drive; thence along present city limits line to point of beginning.
