TITLE! AN ORDINANCE PROVIDING FOR THE DATE AND MANNER OF HOLDING A SPECIAL ELECTION IN AREA NO.2, NOMMAN & DALY ADDITION, A PORTION OF 1ST ADDITION TO VISTA HOMES AND ADJACENT AREA, ON THE 16TH DAY OF DECEMBER, 1959, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE SAID TERRITORY FOR THEIR ADOPTION OR REJECTION A PROPOSAL TO ANNEX AREA NO.2, BOWMAN & DALY ADDITION, A PORTION OF 1ST ADDITION TO VISTA HOMES AND ADJACENT AREA TO THE CITY OF ALBANY, OREGON, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DAY AND TIME FOR ELECTION

That in a menner provided by law and in this Ordinance and for the purpose set forth herein, a special election shall be held in Area No.2, Bowman & Daly Addition, a portion of 1st Addition to Vista Homes and adjacent area, Linn County, Oragon, as below described on the 18th day of December, 1959, commencing at the hour of 8 o'clock a.m. on the said day, Pacific Standard Time.

Section 2: VOTING PLACE

That the following is hereby designated as the voting place of the said election: Geary St. Market at 28th Ave. and Geary St., Albany, Oregon.

Section 3: JUDGE AND CLERKS

That the Judge and Clerks of the said special election who shall supervise the election within the below described territory shall be:

Section 4: NOTICE

The City Recorder shall cause notice of the said special election to be given by publication thereof in a newspaper of general circulation within the city once a week for four (4) consecutive weeks, first date of publication to be the 20th day of November, 1959, and said notice shall state the time, voting place and a description of the territory proposed to be annexed.

Section 5: POSTED NOTICES

The Recorder, in addition to the notice required in Section 4 above, shall cause to be posted in four (4) conspicuous places within the territory proposed to be annexed at least ten (10) days before the date of the special election, notices of the special election in the following form:

NOTICE IS HEREBY GIVEN that on the 18th day of December, 1959, at the Geary St. Market, 28th Ave. and Geary St., Albany, Oregon, a special election will be held concerning the proposed annexation of the following described territory to the City of Albany, to-wit:
