TITLE: AN ORDINANCE PROVIDING FOR THE DATE AND NANNER OF HOLDING A SPECIAL ELECTION IN AREA NO.3, SOUTH ALBANY ADDITION, ELKINS ADDITION, BISHOP ACRES AND ADJACENT AREA ON THE 18TH DAY OF DECEMBER, 1959, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE SAID TERRITORY FOR THE IR ADOPTION OR REJECTION A PROPOSAL TO ANNEX AREA NO.3, SOUTH ALBANY ADDITION, ELKINS ADDITION, BISHOP ACRES AND ADJACENT AREA TO THE CITY OF ALBANY, OREGON, AND DECLARING AN EMERGENCY.

THE FEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 5: POSTED NOTICES

The Recorder, in addition to the notice required in Section 4 above, shall cause to be posted in four (4) conspicuous places within the territory proposed to be annexed at least ten (10) days before the date of the special election, notices of the special election in the following form:
