##  ORGEON, COMHGUOUS TO THE SOUTHEASTERLY BCUNDARY OF HAWTHORNE PARK ADDITION TO THE CITY of ALBAIY, LINN COUNTY, OREGON.

Whersas, the 22nd day of Wovember, 1960, at a regular Council meeting, the City of Albany, Orogon, did duly pass Ordinance No. 2927, wherein it was provided that a publie haaring would be held on the 14th day of December, 1960, concerning advisability of annoxation of certain property owned by the First Mathodist Church of Albeny, Oregon, contiguous to the Scutheasterly boundary of Hawthorne Park Addition to the City of Albany, Linn County, Oregon, and
