#### ORDINANCE NO. 2961

TITIE: An Ordinance providing for the date and manner of holding a special election in a portion of Fir Caks Addition and First Addition to Fir Caks Addition on the 23rd day of Jume, 1961, for the purpose of submitting to the legal voters of the said territory for their adoption or rejection a proposal to annex a portion of Fir Caks Addition and First Addition to Fir Caks Addition to the City of Albany, Oregon, and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

## Section 1: DAY AND TIME FOR ELECTION

That in a manner provided by law and in this Ordinance and for the purpose set forth herein, a special election shall be held in a portion of Fir Oaks Addition and First Addition to Fir Oaks Addition, Linn County, Oregon, as below described on the 23rd day of June, commencing at the hour of 8 o'clock a.m. on the said day, Pacific Standard Time.

#### Section 2: VOTING PLACE

That the following is hereby designated as the voting place of the said election:
T. B. Jackson residence, 3015 South Liberty Street, Albany, Oregon

#### Section 3: JUDGE AND CLERKS

That the Judge and Clerks of the said special election who shall supervise the election within the below described territory, shall be:

Marjorie E. Oberson, Judge Mildred E. Cox, Clerk June F. Sorseth, Clerk

#### Section 4: NOTICE

The City Recorder shall cause notice of the said special election to be given by publication thereof in a newspaper of general circulation within the city once a week for four (4) consecutive weeks, first date of publication to be the 26th day of May, 1961, and said notice shall state the time, voting place and a description of the territory proposed to be annexed.

### Section 5: POSTED NOTICES

The Recorder, in addition to the notice required in Section 4 above, shall cause to be posted in four (4) conspicuous places within the territory proposed to be annexed at least ten (10) days before the date of the special election, notices of the special election in the following form:

## "SPECIAL ELECTION NOTICE"

NOTICE IS HEREBY GIVEN that on the 23rd day of June, 1961, at the T. B. Jackson residence, 3015 South Liberty Street, Albany, Oregon, a special election will be held concerning the proposed annexation of the following described territory to the City of Albany, to-wit:

Beginning at the point of intersection of the E line of Umatilla St. and the present city limits line; thence S 0°26'W to the NE corner of the intersection of 29th Avenue, proposed, and Umatilla St., proposed, said point being S 0°26'W 884.72' from the point where the S line of the Albany drainage ditch intersects the E line of Umatilla Street; thence N 89°34'W along the N line of 29th Avenue, proposed,

and continuing on the same bearing to the E line of Fir Oaks 2nd Addition; thence Sly along said E boundary of Fir Oaks 2nd Addition to the NE corner of Tr 54 in said addition; thence Sly along the E line of said tract to a point which is S 0°26'W 208.08' from the NE corner of said Tr 54; thence S 89°34'E 116.8'; thence S 0°26'W 110'; thence N 89°34'W 116.8' to E line of Tr 54; thence Sly along the E line of said Tr 54 to the SE corner thereof; thence N 66°19'W 330' to the SW corner of Tr 52 in said addition; thence N 62°32'W 334.03'; thence N 0°26'E to the S line of Oakwood Drive and continuing on the same bearing to the S line of Tr 18, Fir Oaks Addition Revised; thence N 89°34'W to the E line of Park Terrace; thence Nly along said E line of Park Terrace to the centerline of vacated 31st Avenue; thence S 89°34'E to a point which is N 85°34'W 112.6' from the W line of Lawnridge Street; thence N 0°26'E to the S line of the Albany drainage ditch; thence NWly to the SW corner of Tr 30, Fir Oaks Addition Revised; thence N 14°12'W to the intersection of the present city limits, being the N line of 27th Avenue; thence Ely along said city limits to the point of beginning,

which election will be held at 8 o'clock in the morning and will continue until 8 o'clock in the afternoon Pacific Standard Time of the said day.

Registered voters in said territory are invited to vote upon the proposed annexation.

## Section 6: PURPOSE OF ELECTION

At the said special election, the proposed annexation of the territory described below shall be submitted to the legal voters of the said territory for their adoption or rejection as hereinafter set forth in Section 7.

#### Section 7: SAMPLE BALLOT

The ballot title of the proposed annexation submitted to the registered voters of the said territory shall be as follows:

AN ACT to annex the following described territory to the City of Albany:

Beginning at the point of intersection of the E line of Umatilla Street and the present city limits line; thence S 0°26'W to the NE corner of the intersection of 29th Avenue, proposed, and Umatilla Street, proposed, said point being S 0°26'W 884.72' from the point where the S line of the Albany drainage ditch intersects the E line of Umatilla Street; thence N 89°34'W along the N line of 29th Avenue, proposed, and continuing on the same bearing to the E line of Fir Oaks 2nd Addition; thence Sly along said E boundary of Fir Oaks 2nd Addition to the NE corner of Tr 54 in said addition; thence Sly along the E line of said tract to a point which is S 0°26'W 208.08' from the NE corner of said Tr 54; thence S 89°34'E 116.8'; thence S 19 along the E line of said Tr 54; to the SE corner thereof; thence N 66°19'W 330' to the SW corner of Tr 52 in said addition; thence N 62°32'W 334.03'; thence N 0°26'E to the S line of Laterood Drive and continuing on the same bearing to the S line of Tr 18, Fir Oaks Addition Revised; thence N 89°34'W to the E line of Park Terrace; thence Nly along said E line of Park Terrace to the centerline of vacated 31st Avenue; thence S 89°34'E to a point which is N 85°34'W 112.6' from the W line of Lawridge Street; thence N 0°26'E to the S line of the Albany drainage ditch; thence NWly to the SW dorner of Tr 30, Fir Oaks Addition Revised; thence N l4°12'W to the intersection of the present city limits, being the N line of 27th Avenue; thence Ely along said city limits to the point of beginning.
