ORDINANCE NO. 3055

AN ORDINANCE PROVIDING FOR THE DATE AND MANNER OF HOLDING A SPECIAL ELECTION IN THE CITY OF ALBANY, OREGON ON THE 3RD DAY OF JUNE, 1963, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF ALBANY THE FOLLOWING PROPOSAL: A SPECIAL LEVY IN THE AMOUNT OF \$8,500.00 FOR THE INSTALLATION OF A TRAFFIC SIGNAL AT THE INTERSECTION OF QUEEN AVENUE AND ELM STREETS IN THE CITY OF ALBANY, SAID LEVY TO BE OUTSIDE THE 6% LIMITATION; DESIG-NATING POLLING PLACES, THE HOURS OF ELECTION, NOTICE OF ELECTION, THE BALLOT FORM AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: SPECIAL ELECTION CALLED

The proposition set forth in Section 2 of this Ordinance shall be submitted in the manner prescribed in this Ordinance to the legal voters of the City of Albany, Oregon, at a special election to be held on the 3rd day of June, 1963.

Section 2: PROPOSITION TO BE VOTED AT THE ELECTION

The proposition to be voted at the election shall be submitted to the legal voters of the City of Albany for their approval or rejection shall be as follows:

"Shall there be levied a special tax in the amount of \$8,500.00 for the use in the installation of a traffic light at the intersection of Queen Avenue and Elm Streets in the City of Albany, Linn County, Oregon, said levy to be outside of the 6% limitation in Section 2 of Article XI of the Oregon Constitution?"

Section 3: DESIGNATION OF POLLING PLACES, POLLING BOOKS AND JUDGES

The polling places hereby designated are as follows:

The City Recorder shall prepare the poll books for the election and the judges and clerks of the election shall be appointed by the City Recorder with the consent of the City Council.

Section 4: HOURS OF ELECTION

The polls for the special city election shall be open in each of the polling places at 8 o'clock a.m., Pacific Standard Time, and shall be kept open until 8 o'clock p.m., Pacific Standard Time.

Section 5: NOTICE OF ELECTION

Notice of the election shall be given by publication twice in a newspaper of general circulation in the City of Albany, not more than twenty (20) days nor less than ten (10) days before the election. Notice of the election shall be posted for not less than twenty (20) days before the election in three (3) public places within the city. Notice in the newspaper and those posted shall be substantially in the following form:

"NOTICE OF ELECTION

On the 3rd day of June, 1963, in the City of Albany, Linn County, Oregon, from 8 o'clock a.m., Pacific Standard Time, until 8 o'clock p.m., Pacific Standard Time, a special election shall be held at which the following measure will be submitted to the voters for their approval:

SPECIAL LEVY FOR TRAFFIC SIGNALS

Shall the City of Albany, Linn County, Oregon levy a special tax for the installation of traffic signals at the intersection of Queen Avenue and Elm Streets in the City of Albany? Said tax shall be in the amount of \$8,500.00 outside of the 6% limitation for the tax year 1963-1964.

The following is the form in which the question shall be printed on the official ballot:

"Vote Yes or No. Mark an "X" in the square for the answer voted for:

This issue initiated by the people through petition to the City Council of the City of Albany and there referred back to the people by the City Council for decision.

Shall the City of Albany, Linn County, Oregon levy a special tax for the tax year 1963-1964 in the amount of \$8,500.00 outside the 6% constitutional limitation for the installation of a traffic control signal at the intersection of Queen Avenue and Elm Streets in the City of Albany, Linn County, Oregon.
