# ORDINANCE NO. 3097

AN ORDINANCE PROVIDING FOR THE DATE AND MANNER OF HOLDING A SPECIAL ELECTION IN THE CITY OF ALBANY, OREGON, ON THE 26TH DAY OF FEBRUARY, 1964, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF ALBANY THE FOLLOWING PROPOSAL:

A special continuing levy in the amount not to exceed \$7,500.00

A special continuing levy in the amount not to exceed \$7,500.00 to be used for Mosquito Control, said levy to be outside the 6% limitation;

DESIGNATING POLLING PLACES, THE HOURS OF ELECTION, NOTICE OF ELECTION, THE BALLOT FORM AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

#### Section 1: SPECIAL ELECTION CALLED

The proposition set forth in Section 2 of this Ordinance shall be submitted in the manner prescribed in this Ordinance to the legal voters of the City of Albany, Oregon at a special election to be held on the 26th day of February 1964.

#### Section 2: PROPOSITION TO BE VOTED AT THE ELECTION

The proposition to be voted at the election shall be submitted to the legal voters of the City of Albany for their approval or rejection shall be as follows:

"Shall there be levied a special continuing five (5) year levy in the amount not to exceed \$7,500.00 per year for the use of Mosquito Control in the City of Albany, Linn County, Oregon, said levy to be outside of the 6% limitation in Section 2 of Article XI of the Oregon Constitution?"

## Section 3: DESIGNATION OF POLLING PLACES, POLLING BOOKS AND JUDGES:

The polling places hereby designated are as follows:

Ward One Maple School
Ward Two City Hall
Ward Three Waverly School

The City Recorder shall prepare the poll books for the election and the judges and clerks of the election shall be appointed by the City Recorder with the consent of the City Council.

#### Section 4: HOURS OF ELECTION

The polls for the special city election shall be open in each of the polling places at 8 o'clock a.m. Pacific Standard Time, and shall be kept open until 8 o'clock p.m., Pacific Standard Time.

## Section 5: NOTICE OF ELECTION

Notice of the election shall be given by publication twice in a newspaper of general circulation in the City of Albany, not more than twenty (20) days nor less than ten (10) days before the election. Notice of the election shall be posted for not less than twenty (20) days before the election in three (3) public places within the City. Notice in the newspaper and those posted shall be substantially in the following form:

### "NOTICE OF ELECTION

On the 26th day of February, 1964, in the City of Albany, Linn County, Oregon, from 8 o'clock a.m., Pacific Standard Time, until 8 o'clock p.m., Pacific Standard Time, a special election shall be held at which the following measure will be submitted to the voters for their approval:

'SPECIAL TAX LEVY FOR MOSQUITO CONTROL Shall the City of Albany, Linn County, Oregon, levy a special continuing five (5) year levy for the use of Mosquito Control in the City of Albany? Said tax shall be in the amount not to exceed \$7,500.00 per year outside of the 6% limitation beginning the tax year 1964-65.

The polling places for said election shall be as follows:

Ward One Ward Two Ward Three Maple School City Hall Waverly School

The recorder shall advertise and cause to be posted the notices required by this section. A notice of election required to be given by this Ordinance shall constitute the only notice necessary and all Ordinances and Resolutions in conflict herewith shall not apply to the notice as required to be given of this election.

Section 6: BALLOT FORM

The following is the form in which the question shall be printed on the official ballot:

"Vote YES or NO. Mark an "x" in the square for the answer voted for:

Shall the City of Albany, Linn County, Oregon, levy a special continuing five (5) year levy in the amount not to exceed \$7,500.00 per year beginning the tax year 1964-65 outside the 6% constitutional limitation for the use of Mosquito Control in the City of Albany, Linn County, Oregon.

Section 7: EMERGENCY CLAUSE

WHEREAS, the peace, health and safety of the people of the City of Albany is involved, therefore, an emergency is hereby declared to exist and this Ordinance shall become in full force and effect immediately upon its final passage by the Council and approval by the Mayor.
