ORDINANCE NO. 3233

AN ORDINANCE TO DETERMINE THE ASSESSMENTS AGAINST THE PROPERTY SPECIFICALLY BENEFITED BY THE FIR OAKS SANITARY SEWER EXTENSION NO. 1, AND DECLARING AN EMERGENCY.

RECITALS:

1. The sewer assessment as referred to in this ordinance and previous resolutions and ordinances is "Fir Oaks Sanitary Sewer Extension No. 1."

2. Preliminary resolutions and ordinances prescribing the manner and extent of the improvement are set forth in Resolution Nos. 852 and 853 and in Ordinance No. 2864.

3. The assessments set forth in the following ordinance are based upon the request and recommendation of the City Engineer in compliance with Ordinance No. 2864.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: COST

The total cost of the sewer construction for the Fir Oaks Sanitary Sewer is hereby determined to be \$10,242.73. The following tabulation represents a breakdown of the costs to be assessed against the property particularly benefited thereby:

Total Construction Cost Engineering, Legal and Administrative (13%) TOTAL \$1,178.37 \$10,242.73

A Portion of this total assessable cost, in the amount of \$92.14, is to be assessed directly to Tax Lot 2500, Tax Lot 2800 and Tax Lot 3300 Map 11 4W 13 BD.

The cost of the Fir Oaks Sanitary Sewer Extension No. 1 is to be assessed against fifteen properties containing a total of 239,173 assessable square feet on the basis of \$0.042440367 per square foot.
