ORDINANCE NO. 3282

TITLE: An Ordinance amending Sections 11, 18 and 23 of Ordinance No. 2751, as the same pertains to the parking of motor vehicles in the City of Albany and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: AMENDMENT

Section 11 of Ordinance No. 2751 is amended to read as follows:

"Section 11. PROHIBITIVE PARKING In addition to the provisions of the motor vehicle laws of Oregon prohibiting parking, no person shall park:

- a) A vehicle upon any bridge, viaduct, or elevated structure used as a street.
- b) A vehicle in any alley, except to load or unload persons or materials not to exceed 15 consecutive minutes in any one hour period. A vehicle may park in any alley between the hours of 8 o'clock a.m. and 5 o'clock p.m. if it is activily needed to make installations or repairs to equipment or buildings or for building construction, providing the vehicle wont cause the alley to be blocked to other traffic.
- c) Upon any street, alley way or parking strip in the City of Albany, Oregon, any truck, tractor with trailer, trailer attached to or carried upon any truck, or any truck having a load capacity of 1% tons or more over night and on Sundays and Holidays.
- d) The vehicle upon any street for the principle purpose of:
 - 1- Displaying such vehicle for sale.
 - 2- Greasing or repairing such vehicle, except repairs necessitated by emergency.
 - 3- Displaying, advertising from such vehicle.
 - 4- Selling merchandise from such vehicle, except in a duly established market place or when so authorized or licensed under the Ordinances of this city.
 - 5- Storage or junkage or dead storage for more than 24 hours.
- e) A vehicle upon any parkway, except where specifically authorized."

Section 2: AMENDEMNT

Section 18, of Ordinance No. 2751 is amended to read as follows:

"Section 18. No person shall park any vehicle in any metered parking space, except as otherwise permitted by this Ordinance, without immediately depositing in the parking meter adjacent to such space such lawful coin or coins of the United States as are required by such meter and as designated by directions on the meter, and when required by directions of the meter, unless the parking meter indicates at the time such vehicle is parked that an unexpired portion remains of the period for which a coin or coins has been previously deposited. Parking shall be permitted in any metered parking space without depositing a coin in the meter subject to the following conditions:

- a) The vehicle is parked in response to an emergency call and its official emergency light is in operation while it is parked.
- b) The vehicle is being used in the process of repairing streets, sewers or other public facilities and its official emergency light is in operation while parked.
- c) The vehicle is loading or unloading passengers or freight and the metered parking space is designated as a loading zone during certain specified hours."

Section 3: AMENDMENT

Section 23 of Ordinance No. 2751 is amended by dividing into two sections, being Section 23A and 23B to read as follows:

"Section 23A. PARKING METER HOODS AND BARRICADED PARKING SPACES. The City Recorder may issue parking meter hoods to contractors or utility companies engaged in construction, reconstruction or repair of a building or installation of equipment, to applicants engaged in moving furniture or fixtures in or out of buildings and to a manager of a building that is to be used for a public gathering and that is adjacent to a street where parking meters are located. Such hoods shall be issued only when space in alleys or other unmetered areas are not usable within a reasonable distance of the place where the applicant proposes to use the hood. Hoods shall be issued only for each particular construction job or use. The deposit of \$1.00 shall be paid for each parking meter hood when issued and this deposit shall be refunded upon return of the parking meter hood. There shall be an additional charge of 50¢ per day or \$2.00 per week for each day or week the hood shall be in use, upon proof of a continuing need. In the event that parking meter spaces are barricaded during the course of construction so that they shall not be available for the use of parking by the general public, there shall be a charge of 50¢ per day or \$2.00 per week made to the person erecting the barricade."

"Section 23B. SERVICE PARKING PERMITS. The City Recorder may issue an annual 'service parking permit' to applicants engaged in the business of making installations, repairs or engaged in construction, but not for sales or business calls. This permit must be placed so that it can be read easily through the windshield of the vehicle on the right side thereof and shall be used for the purpose issued in lieu of placing the coin in the meter for a period not to exceed four hours. Vehicles that are to be parked more than 4 hours for a purpose authorized by law must obtain a meter hood. Annual service parking permits shall be issued for a period beginning July 1 and ending one year on June 30 the following year, shall be prenumbered and a record kept containing the date, name of applicant, receipt number and any other pertinent information. The fee for an annual service permit shall be \$5.00 each annually. Such permit shall not be obtainable for less than the cost of an annual permit."

Section 4: EMERGENCY DECLARED.

Whereas, the peace, health and safety of the people of the City of Albany requires that this ordinance shall become immediately effective, therefore, an emergency is hereby declared to exist and this Ordinance shall become in full force immediately upon final passage by the Council and approval by the Mayor.
