ORDINANCE NO. 3294

TITLE:

An Ordinance providing for the date and manner for holding a special election in the City of Albany, Oregon, on the 21st day of April, 1967 for the purpose of submitting to the legal voters of the City of Albany an act to provide for a special continuing 10 year tax levy of \$21,200.00 per year outside the 6% limitation beginning with the year 1967-1968 to provide funds for the payment of additional employees in the Fire Department of the City of Albany and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: SPECIAL ELECTION CALLED.

That the proposition set forth in Section 2 of this Ordinance shall be submitted in the manner prescribed in this Ordinance to the legal voters of the City of Albany, Oregon, a special election to be held on the 21st day of April, 1967.

Section 2: PROPOSITION TO BE VOTED.

At the election, there shall be submitted to the legal voters of the City of Albany for their approval or rejection the following proposition:

"Shall the City of Albany levy a special continuing ten (10) year tax levy of \$21,200.00 per year outside the 6% limitation as provided in the Oregon Constitution, beginning with the tax year 1967-58 to provide for the payment of salaries for additional employees in the Fire Department of the City of Albany."

Section 3: DESIGNATION OF POLLING PLACES, POLL BOOKS AND JUDGES.

The polling places are hereby designated as follows:

WARD ONE WARD TWO WARD THREE Maple School Lafayette School Waverly School

The poll books shall be prepared by the Recorder of the City of Albany pursuant to the laws and ordinances of the City of Albany and the judges and clerks of election shall be appointed by the City Recorder of the City of Albany and shall serve as judges and clerks of the special city election.

Section 4: HOURS OF ELECTION.

The polls for the special city election shall be kept open at the polling places from 8 o'clock a.m. until 8 o'clock p.m.

Section 5: NOTICE OF ELECTION.

Notice of election shall be given by publication twice in a newspaper of

Page -1-Ordinance No. 3294 general circulation in the City of Albany, Oregon, not more than twenty (20) days, nor less than ten (10) days before election. Notice of election shall be posted for not less than twenty (20) days before the election in three (3) public places in the City. The notice in the newspaper and those posed in three public places shall be in substantially the following form:

"NOTICE OF ELECTION

"On the 21st day of April, 1967, in the City of Albany, Linn County, Oregon, from 8:00 a.m. until 8:00 p.m., a special election shall be held at which time the following proposition shall be submitted to the voters for their approval:

'Shall the City of Albany make a special continuing ten (10) year tax levy of \$21,200.00 per year outside the 6% limitation imposed by the Oregon Constitution, beginning with the tax year 1967-1968, to provide for payment of salaries of additional employees of the Fire Department of the City of Albany?

"The polling places in the City for the special election shall be as follows:

Ward One Ward Two Ward Three Maple School Lafayette School Waverly School

"The city council has, by Ordinance, directed the City Recorder to select judges and clerks to serve at the special election at the polling places as designated.

"WITNESS my hand and seal of the City of Albany this _____day of March, 1967.

City Recorder"

The recorder shall advertise and post or cause to be posted the notice required by this section. The notice of election required to be given by this Ordinance shall constitute the only notice necessary and all Ordinances or resolutions in conflict herewith shall not apply to the notice as required by this election.

Section 6: BALLOT FORM

The following is the manner and form in which the question shall be printed on the official ballot:

Page - 2 -Ordinance No. 3294 "VOTE YES OR NO. Mark an "X" in the square for the answer worted for:

Referred to the legal voters of the City of Albany by the city council:

'Shall the City of Albany make a special continuing ten (10) year tax levy of \$21,200.00 per year outside of the 6% limitation imposed by the Oregon Constitution, beginning with the tax year 1966-67, to provide for payment of salaries for additional employees in the Fire Department of the City of Albany?

Section 7: EMERGENCY CLAUSE

WHEREAS, in the betterment of the public health, safety and general welfare of the citizens of Albany, Oregon, this matter should be disposed of at the earliest possible moment, therefore, an emergency is hereby declared to exist and this Ordinance shall become immediately effective upon its passage by the council and approval by the mayor.
